## **ORDER IN COUNCIL 102/74**

under *The Saskatchewan Housing Corporation Act, 1973*

To His Honour

THE LIEUTENANT GOVERNOR IN COUNCIL:

The undersigned has the honour to report:

**1** That by Order in Council No. 361/73, dated March 16, 1973, issued under the authority of The Crown Corporations Act, the following persons were constituted as the Saskatchewan Housing Corporation:

Honourable E. I. Wood, Regina, Chairman and Member of the Executive Council to whom the Corporation shall be responsible;

William Davies, Regina;

Harry C. Gemmel, Regina;

D. M. Wallace, Regina;

H. E. Wellman, Saskatoon; and

W. T. Wardill, Eatonia.

**2** That Section 44 of the Saskatchewan Housing Corporation Act, 1973, provides as follows:

**44** Saskatchewan Housing Corporation as at present constituted under The Crown Corporations Act is hereby continued as the corporation referred to in section 3, subject to such changes in personnel as may be made under section 5.

**3** That Section 5(1) of the Saskatchewan Housing Corporation Act, 1973, provides as follows:

**5(1)** The affairs and business of the corporation shall be conducted by a board of directors consisting of not less than three persons appointed by the Lieutenant Governor in Council.

**4** That it is deemed advisable and for the public good that certain changes in personnel of the Saskatchewan Housing Corporation be made.

The undersigned has the honour to recommend that Your Honour's Order do issue, under authority of the Saskatchewan Housing Corporation Act, 1973, S.S. 1973, c. 93, effective on the date of this Order:

(a) terminating the appointment of the following members of the Board of Directors of the Saskatchewan Housing Corporation:

Honourable E. I. Wood, Regina, Chairman and Member of He Executive Council to whom the Saskatchewan Housing Corporation shall be responsible;

William Davies, Regina;

- (b) appointing Honourable Don Cody, Regina, as a member of the Board of Directors of the Saskatchewan Housing Corporation;
- (c) designating Honourable Don Cody as Chairman of the Board of Directors of the Corporation and the Member of the Executive Council to whom the Saskatchewan Housing Corporation shall be responsible;
- (d) confirming that in consequence of the above change in membership of the Board, the following persons are now members of the Board of Directors of the Saskatchewan Housing Corporation:

Honourable Don Cody, Regina, Chairman and Member of the Executive Council to whom the Saskatchewan Housing Corporation shall be responsible;

Harry C. Gemmel, Regina;

D. M. Wallace, Regina;

H. E. Wellman, Saskatoon;

W. T. Wardill, Eatonia.
