CHAPTER 15
An Act to amend The Statute Law

(Assented to June 29, 1989)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title 1 This Act may be cited as *The Statute Law Amendment Act, 1989*.

- 2(1) *The Highway Traffic Act* is amended in the manner set forth in this section.
- (2) Subsection 109(1) is amended by striking out "this act" and substituting "this Act".
- (3) Subsection 111(1) is amended by relettering clauses (e) to (h) as clauses (d) to (g) respectively.

Words in Acts replaced

3 The Acts listed in column 1 of Schedule 1 are amended in the provisions listed opposite them in column 2 by striking out the words listed in column 3 and substituting the words listed in column 4.

Words in Acts added

4 The Acts listed in column 1 of Schedule 2 are amended in the provisions listed opposite them in column 2 by adding the words listed in column 3 after the words listed in column 4.

References to *The Department of Finance Act, 1983* amended

5 The Acts listed in column 1 of Schedule 3 are amended in the provisions listed opposite them in column 2 by striking out "*The Department of Finance Act, 1983*" and substituting "*The Financial Administration Act*".

Coming into force

6 This Act comes into force on the day of assent.
