#### CHAPTER T-1.1

An Act respecting the Tabling of Documents and Certain Consequential and Other Amendments to Other Acts resulting from the enactment of this Act

(Assented to December 22, 1991)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### SHORT TITLE AND INTERPRETATION

Short title1 This Act may be cited as The Tabling of Documents Act, 1991.

Interpretation2 In this Act:

"document"(a) "document" means a document that is required by an Act to be laid before the Assembly; "preparer"(b) "preparer" means:

(i) the department, agency, board or commission of the Government of Saskatchewan or Crown corporation that; or

(ii) the person who;

is required by an Act to prepare and submit a document to the presenter;

"presenter"(c) "presenter" means the Lieutenant Governor in Council, member of the Executive Council or other person who is required by an Act to lay a document before the Assembly.

#### TABLING OF DOCUMENTS

Submission of document

3(1) Subject to subsection (2), a preparer shall submit the document, which the preparer is required to prepare and submit, to the presenter within 90 days after the end of the period for which the document is prepared.

(2) Where an Act requires a document to be submitted within a period shorter than the period mentioned in subsection (1), the preparer shall submit the document to the presenter within that shorter period.

Tabling of document

4(1) Subject to subsection (2), a presenter shall lay the document before the Assembly within 15 sitting days after the day on which the presenter received the document.

(2) Where the presenter is the Lieutenant Governor in Council:

(a) the President of the Executive Council; or

(b) a member of the Executive Council designated by the President of the Executive Council; shall lay the document before the Assembly.

Documents to be submitted only once

5 This Act does not require a document to be laid before the Assembly more than once.
