## CHAPTER 17

An Act to amend the Statute Law

(Assented to May 4, 1993)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Statute Law Amendment Act, 1993*.
