## CHAPTER 21

### An Act to amend *The SaskEnergy Act*

(Assented to April 30, 1996)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 This Act may be cited as *The SaskEnergy Amendment Act, 1996*.

#### S.S. 1992, c.S-35.1 amended

2 *The SaskEnergy Act* is amended in the manner set forth in this Act.

#### Section 23 amended

3 Subsection 23(1) is amended by striking out "high pressure".

#### Section 60 amended

4(1) Subsection 60(1) is repealed and the following substituted:

"(1) In this section and in section 61:

(a) '**gas gathering and processing system**' means an interconnected system consisting of all or any combination of flowlines, pipelines, meters, dehydrators, compressors and gas processing plants, where the system:

(i) collects gas from gas wells, oilfield batteries or both; and

(ii) transfers the gas to the TransGas gas transmission pipeline at the location where TransGas agrees to receive the gas;

(b) '**TransGas gas transmission pipeline**' means an existing TransGas gas transmission pipeline or a TransGas gas transmission pipeline that TransGas plans or agrees to construct;

(c) '**transportation of gas**' means the movement of gas by means of any gas pipeline and compression facilities, where that movement is:

(i) downstream of the point where physical possession of the gas is transferred to a gas transmission pipeline from:

(A) a gas gathering and processing system;

(B) a gas gathering system;

(C) an interconnected interprovincial or international gas transmission pipeline; or

(D) a gas storage facility; and

(ii) upstream of:

(A) the outlet of the shut-off valves of gas transmission pipelines at stations where pressure reduction first occurs for eventual delivery of gas to consumers of gas in Saskatchewan; or

(B) the point where physical possession of the gas is transferred to:

(I) an interconnected interprovincial or international gas transmission pipeline;

(II) a consumer of gas in Saskatchewan who takes delivery of the gas from a gas transmission pipeline; or

(III) a gas storage facility".

**(2) The following subsections are added after subsection 60(4):**

"(5) TransGas' exclusive right to transport gas pursuant to subsection (2) does not apply to the transportation of gas from a gas gathering and processing system to an oilfield production facility in Saskatchewan where the gas gathering and processing system and oilfield production facility are owned by the same person.

"(6) TransGas' exclusive right to transport gas pursuant to subsection (2) does not apply to the transportation of gas to and from a gas storage facility where the gas storage facility is integrated in a gas gathering and processing system".

**Coming into force**

5 This Act comes into force on assent.
