## CHAPTER 38

An Act to amend *The Crown Corporations Act, 1993* and to make consequential amendments to other Acts

(Assented to June 17, 2004)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Short title**

**1** This Act may be cited as *The Crown Corporations Amendment Act, 2004*.

**2(1)** Section 6 of *The Crown Corporations Act, 1993* is amended in the manner set forth in this section.

**(2) The following clauses are added after clause (1)(r):**

“(r.1) establish, operate, administer or manage programs or policies that promote, enhance or foster employment and career opportunities in Crown corporations and subsidiary Crown corporations;

“(r.2) for the purposes of clause (r.1) and subject to subsection (8), provide financial assistance to post-secondary educational institutions in Saskatchewan that are recognized by the Minister of Learning;

“(r.3) establish, operate, administer or manage programs or policies that promote or enhance business opportunities in and for Saskatchewan”.

**(3) Subsection (8) is repealed and the following substituted:**

“(8) CIC shall obtain the approval of the Lieutenant Governor in Council before providing any financial assistance pursuant to clause (1)(r.2), or making any grant pursuant to subsection (7), that is in excess of \$50,000 in any fiscal year”.

**3 Clause 8(4)(b) of *The Financial Administration Act, 1993* is amended by striking out “*The Crown Corporations Act, 1978*” and substituting “*The Crown Corporations Act, 1993*”.**

**4(1)** *The Public Service Superannuation Act* is amended in the manner set forth in this section.

**(2) Subclause 60.2(1)(b)(ii) is repealed and the following substituted:**

“(ii) a superannuation plan established or continued pursuant to *The Crown Corporations Act, 1993*”.

**(3) Subsection 60.2(2) is amended by striking out “*The Crown Corporations Act, 1978*” and substituting “*The Crown Corporations Act, 1993*”.**

**5 Subsection 19(1) of *The Superannuation (Supplementary Provisions) Act* is amended by striking out “*The Crown Corporations Act*” and substituting “*The Crown Corporations Act, 1993*”.**

R.S.S. 1978, c.W-4, section 9 amended

**6 Subclause 9(1)(k)(xi) of *The Wascana Centre Act* is amended by striking out “*The Crown Corporations Act, 1978*” and substituting “*The Crown Corporations Act, 1993*”.**
