## CHAPTER 65

### An Act to amend the Statute Law

(Assented to November 30, 2004)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 This Act may be cited as *The Statute Law Amendment Act, 2004*.
