## **CHAPTER 20**

An Act to amend certain Statutes with respect  
to matters concerning Professional Discipline

(Assented to May 20, 2010)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

### **PART I Short Title**

**Short title**

**1** This Act may be cited as *The Miscellaneous Statutes (Professional Discipline) Amendment Act, 2010*.

### **PART II *The Agrologists Act, 1994***

(2) For the purposes of this section, a proceeding is commenced when the professional conduct committee, pursuant to subsection 24(1), is requested by the council to consider a complaint or is in receipt of a written complaint alleging that a member is guilty of professional misconduct or professional incompetence”.

**56(1)** Subject to subsections (2) to (5), this Act comes into force on assent.
