# **CHAPTER 26**

An Act to amend The Parks Act

(Assented to May 16, 2012)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 This Act may be cited as The Parks Amendment Act, 2012.

S.S. 1986, c.P-1.1 amended

2 The Parks Act is amended in the manner set forth in this Act.

Section 15 amended

3(1) Subsection 15(1) is repealed and the following substituted:

"(1) In this section, **'invested private capital'** means expenditures that a person who seeks a disposition will make, pursuant to an agreement, to complete a project related to that disposition but does not include any expenditures:

(a) using moneys from the Government of Canada or the Government of Saskatchewan, including money provided by way of a grant, loan, guarantee or other means; or

(b) made for the development of a property that is subject to a recreational lease".

## (2) Subsection 15(2) is amended:

(a) in subclause (b)(iii) by striking out "invested capital" and substituting "invested private capital"; and

(b) in subclause (c)(iii) by striking out "invested capital" and substituting "invested private capital".

#### Section 27 amended

## 4 The following clause is added after clause 27(1)(p):

"(p.1) for the purposes of subsection 32(1), prescribing provisions of this Act or the regulations for which an enforcement officer may order a person to cease a contravention or order him or her to leave park land and to remain out of park land for a period of 72 hours".

#### Section 32 amended

5(1) Subsection 32(1) is repealed and the following substituted:

"(1) If an enforcement officer reasonably believes that a person is contravening a prescribed provision of this Act or the regulations, the enforcement officer may order that person to cease the contravention or may order him or her to leave park land and to remain out of park land for a period of 72 hours".

(2) Clause 32(2)(b) is amended by striking out "48 hours" and substituting "72 hours".

#### Section 34 amended

**6(1)** Subsection 34(1) is amended by striking out "\$1,000" and substituting "\$50,000".

## (2) The following clause is added after clause 34(2)(a):

"(a.1) the person pay any costs to reclaim, or mitigate damage caused to, any natural, cultural, historic or prehistoric resources as a result of the contravention in the amount, and within the time, determined by the judge and stated in the order".

## (3) Subsection 34(3) is amended by adding "or (a.1)" after "clause (2)(a)".

Schedule I, Part C amended

7(1) Part C of Schedule I is amended in the manner set forth in this section.

#### (2) The description of Cypress Hills Provincial Park is amended:

#### (a) by repealing subclause (a)(i) and substituting the following:

"(i) the south-west quarter, excluding the portion of Highway 271 right of way"; and

#### (b) by repealing clause (c) and substituting the following:

"(c) in Township 8, in Range 26, all those lands described below, except those portions for roadways as shown on Plan Nos. 62 S C04451 and 80 S C08664, both plans in the Land Surveys Directory:

(i) Sections 15 to 20, inclusive, and Legal Subdivisions 1 to 5, inclusive, 12 and 13 of Section 21;

(ii) the west halves of Legal Subdivisions 11 and 14 of Section 21;

(iii) that portion of the south-west quarter of Section 27 lying west of Highway No. 21 as shown on Registered Plan No. 80 SC 08664 in the Land Titles Office for the Swift Current Land Registration District;

(iv) the south half of Section 28 and those portions of the north-east and north-west quarters of that Section contained within the following boundary:

(A) commencing at the south-east corner of the north-east quarter;

(B) thence north along the east boundary of the north-east quarter a distance of 704 feet;

(C) thence west a distance of 2808 feet to a point 628 feet perpendicularly north of the south boundary of the north-west quarter;

(D) thence south perpendicularly to the south boundary of the north-west quarter to the point of intersection with the south boundary;

(E) thence east along the south boundary of the north-west and north-east quarters to the point of commencement;

(v) Sections 29 to 32, inclusive".

## (3) The description of Douglas Provincial Park is amended:

## (a) by repealing paragraph (b)(i)(C) and substituting the following:

"(C) Sections 22, 24, 25, 27, 28, 32, 33, 35 and 36, excepting the developed road allowance to the west of Section 32 and, in Section 36, excepting those portions taken for Highway No. 19 as shown on Plan No. 61 MJ 05157 and for CPR right of way and extra right of way as shown on Plan No. 67 MJ 11017, both plans in the Land Surveys Directory";

## (b) by repealing subclause (b)(iv); and

(c) in subclause (c)(x) by striking out "north-west and south-east quarters" and substituting "south-east quarter".

## (4) The description of Lac La Ronge Provincial Park is amended:

(a) in the portion preceding clause (a) by adding "and excepting Highways Nos. 102 and 915" after "described as follows"; and

(b) in subclause (a)(xiv) by striking out "Walker Creek" wherever it appears and in each case substituting "Wheeler Creek".

(5) Subclause (a)(viii) of the description of Makwa Lake Provincial Park is amended by striking out "Plan Nos. BQ 4712 and 60 B 07794" and substituting "Plan Nos. BQ 4712 and 72 B 06286".

#### (6) The description of Moose Mountain Provincial Park is amended:

(a) by repealing subclause (a)(i) and substituting the following:

"(i) the north half of Section 7, including the small roadway off Highway No. 9 as shown on Plan No. 62 R 27639 in the Land Surveys Directory";

#### (b) by repealing subclause (a)(iv) and substituting the following:

"(iv) Sections 14 to 23, inclusive, including the small roadway off Highway No. 9 in Section 18 as shown on Plan No. 62 R 27639 in the Land Surveys Directory";

(c) in subclause (a)(v) by striking out ", including the small roadway off Highway No. 9 in Sections 7 and 18 as shown on Plan No. 62 R 27639 in the Land Surveys Directory"; and

## (d) by repealing paragraph (c)(v)(C) and substituting the following:

"(C) those portions of Legal Subdivision 8 north and east of the Village of Kenosee Lake municipal limit in this area as shown on Plan Nos. 101953087, 69 R 15162, 66 R 26324, 70 R 06940 and 101227722, excluding Parcel 'Y' as shown on Plan No. 102045169 and including the road right of way shown on Plan No. N2021 between said Parcel 'Y' and the Highway No. 9 right of way".

(7) The description of Saskatchewan Landing Provincial Park is amended:

(a) in paragraph (a)(i)(A) by striking out "Plan No. DS 5701" and substituting "Plan No. 102049152"; and

(b) in subclause (c)(iii) by striking out "Plan No. DS 5701" and substituting "Plan No. 102049152".

#### Schedule II amended

8 Schedule II is amended by repealing clause (a) of the description of Brockelbank Hill and substituting the following:

"(a) Sections 24 and 25, excepting the unsurveyed Highway No. 980 right of way, and the east halves of Sections 23 and 26, in projected Township 42, in Range 31".
