CHAPTER 23

An Act to amend The Power Corporation Act

(Assented to November 30, 2016)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as The Power Corporation Amendment Act, 2016.

2 The Power Corporation Act is amended in the manner set forth in this Act.

Section 3 amended

- 3 Subsection 3(2) is amended:
 - (a) in clause (b) by adding "or her" after "his"; and
 - (b) in the portion following clause (d) by adding "or her" after "his".

Section 5.1 amended

- 4 Subsection 5.1(2) is amended:
 - (a) in clause (a) by adding "or her" after "his"; and
 - (b) in clause (b) by adding "or she" after "he".

Section 8 amended

- 5 Subsection 8(1) is amended:
 - (a) in clause (i) by adding "or any other Act" after "Act"; and
 - (b) by repealing clause (j) and substituting:
 - "(j) to exercise any other powers that may be designated and prescribed by the Lieutenant Governor in Council and that the Lieutenant Governor in Council considers are necessary or desirable for the efficient operation of the corporation's business for the public good".

 - (c) by adding "or her" after "him".

- 10(1) Subsection 19(3) is amended by striking out "or claimants are" and substituting "is".
- (2) Subsection 19(4) is amended in the portion preceding clause (a) by adding "or her" after "him".

Section 20 is amended

- 11(1) Subsection 20(1) is amended by striking out "or claimants".
- (2) Subsection 20(3) is amended by adding "or her" after "his".
- (3) Subsection 20(4) is amended by striking out "or claimants" wherever it appears.
- (4) Subsection 20(5) is repealed and the following substituted:
 - "(5) If the costs are not to be paid by the claimant the full amount deposited shall be returned to him or her".
