# **CHAPTER 20**

# An Act to amend *The Crown Corporations Act, 1993* and to make consequential amendments to other Acts

(Assented to June 11, 1998)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

# PART I Short Title

#### Short title

1 This Act may be cited as The Crown Corporations Amendment Act, 1998.

## PART II

# Amendments to The Crown Corporations Act, 1993

#### S.S. 1993, c.C-50.101 amended

**2** *The Crown Corporations Act, 1993* is amended in the manner set forth in this Part.

#### **Section 6 amended**

#### **3** The following subsections are added after subsection 6(6):

"(7) Subject to subsection (8), CIC may make grants on any terms or conditions that it may prescribe to any subsidiary Crown corporation.

"(8) CIC shall obtain the approval of the Lieutenant Governor in Council before making any grant pursuant to subsection (7) that is in excess of \$50,000 in any fiscal year".

#### Section 23 amended

# **4** Subsection 23(3) is repealed and the following substituted:

"(3) The Lieutenant Governor in Council shall designate one member of the board of a subsidiary Crown corporation as the chairperson of the board of the subsidiary Crown corporation and may designate one other member of the board as vice-chairperson of the board".
