# **CHAPTER 16**

An Act to repeal miscellaneous obsolete Statutes and to enact transitional provisions and consequential amendments with respect to certain Statutes being repealed

(Assented to June 21, 2000)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 This Act may be cited as *The Miscellaneous Statutes Repeal (Regulatory Reform) Act*, 2000.

- **3**(1) The Horticultural Societies Act is repealed.
- (2) Notwithstanding the repeal of *The Horticultural Societies Act*, a society that is incorporated pursuant to *The Horticultural Societies Act* and is in existence on the day before this Act comes into force is continued as a body corporate until the earlier of:
  - (a) the expiry of two years after the day on which this Act comes into force; and
  - (b) the day on which the society is continued pursuant to *The Non-profit Corporations Act*, 1995.
- (3) A society described in subsection (2) may apply pursuant to section 174 of *The Non-profit Corporations Act, 1995* for a certificate of continuance.
- (4) The Department of Agriculture and Food shall, on the request of the society, reimburse a society for any fees charged to the society pursuant to *The Non-profit Corporations Act*, 1995 in relation to an application for a certificate of continuance authorized by subsection (3).
