# CHAPTER 50

An Act to make consequential amendments arising from the enactment of *The Interpretation Amendment Act, 2000* 

(Assented to June 27, 2000)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:
