# **CHAPTER 23**

An Act to repeal miscellaneous obsolete Statutes and to enact consequential amendments with respect to a Statute being repealed

(Assented to June 28, 2001)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 This Act may be cited as The Miscellaneous Statutes Repeal (Regulatory Reform) Act, 2001.

(d) in subsection 31(1) by striking out ", the directors of a rural telephone company";

(e) in subsection 31(2) by striking out ", the directors of a rural telephone company";

(f) in subsection 31(4) by striking out ", members of an area authority or board of directors of a rural telephone company" and substituting "or the members of an area authority";

(g) in subsection 32(2) by striking out ", other than rural telephone taxes";

(h) in the portion of section 38 preceding clause (a) by striking out "a company,";

(i) in clause 38(b) by striking out "company or"; and

(j) in subsection 56(2) by striking out "company" and substituting "corporation".

- (4) Subclause 189(1)(a)(iv) of *The Northern Municipalities Act* is repealed.
- (5) Subclause 44(1)(a)(iv) of *The Power Corporation Act* is repealed.
- (6) The Rural Municipality Act, 1989 is amended:
  - (a) by repealing clause 187(1)(d);
  - (b) by repealing subsection 362(3); and
  - (c) by repealing section 391.
- (7) Clause 81(1)(c) of *The Saskatchewan Insurance Act* is repealed.
- (8) Section 37.1 of The Saskatchewan Telecommunications Act is repealed.
- (9) The Telephone Department Act is amended:
  - (a) by repealing clause 2(d);
  - (b) by repealing clause 5(1)(b);
  - (c) in subsection 6(1) by striking out "rural or";
  - (d) in clause 7(a) by striking out "rural or";
  - (e) by repealing clause 7(b);
  - (f) by repealing section 9;
  - (g) in section 11 by striking out "rural or";
  - (h) in subsection 12(1) by striking out "rural or";
  - (i) in subsection 13(1) by striking out "rural or"; and
  - (j) in subsection 14(1) by striking out "rural and".
