CHAPTER 8

An Act to amend the Statute Law

(Assented to June 20, 2001)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Statute Law Amendment Act, 2001*.
