CHAPTER H-1 REG 2

The Health Services Act

Title

1 These regulations may be cited as *The Public Health Services Grants (Regina and Saskatoon) Regulations*.

Interpretation

2 In these regulations:

- (a) “**grant**” means a grant described in section 3 made pursuant to *The Health Services Act*;
- (b) “**per capita grant figure**” means the amount of \$10.65.

Grant payable

3 The minister may annually make a grant to each of The City of Regina and The City of Saskatoon for the provision and operation of public health services.

Calculation of grant generally

4 The amount of the grant to be paid for each year shall be an amount equal to the product derived by multiplying the per capita grant figure by the sum equal to the population of the city as determined in accordance with these regulations.

Grant paid in instalments

5(1) Subject to section 8, the grant for each year shall be paid to each city in two instalments.

(2) The first instalment in each year is one-half of the product derived by multiplying the per capita grant figure by the total number of beneficiaries reported under *The Saskatchewan Hospitalization Act* for the city as of June 30 in the year immediately preceding the year in which the grant is being paid.

(3) Subject to section 8, the final instalment in each year is the product derived by multiplying the per capita grant figure by the total number of beneficiaries reported under *The Saskatchewan Hospitalization Act* for the city as of June 30 in the year in which the grant is being paid, less the total amount of the first instalment of the grant paid in that year.

Date of payment

6 The first instalment of each grant shall be paid on or about May 31 in the year for which the grant is being paid and the second instalment shall be paid on or about November 30 in the year for which the grant is being paid.

Determination of population

7(1) Subject to subsection (2), the population of each city for any year is the total number of beneficiaries reported under *The Saskatchewan Hospitalization Act* for the city as of June 30 of each year.

(2) In a year in which a census is being taken by Statistics Canada, the population of each city for that year as indicated in the published census report of Statistics Canada, shall be compared with the population of the city for the most recent year in which the census had previously been taken, and the population of the city shall be estimated for each intercensal year between the two censal years as if the change of population between the two censal years had occurred at a constant rate.

Amount of grant payable

8(1) Upon determination of the population for each city in accordance with subsection 7(2), the amount of grant that would have been payable using that population figure shall be calculated in accordance with section 4.

(2) Where the amount pursuant to subsection (1) is:

(a) greater than the total of the grants paid to a city pursuant to section 5 for the years under consideration, the minister shall pay the excess to the city;

(b) less than the total of the grants paid to a city pursuant to section 5 for the years under consideration, the minister shall deduct an amount equal to the difference between the two amounts from the grant next payable to the city.
