## ORDER IN COUNCIL

### *The Health Districts Act*

(O.C. 57/96)

31 January 1996

TO THE HONOURABLE  
THE LIEUTENANT GOVERNOR IN COUNCIL

The undersigned has the honour to report that:

**1** *The Health Districts Act* provides, in part, as follows:

**3(2)** Subject to subsections (3) and (4), the Lieutenant Governor in Council may make an order:

- (a) establishing any area within Saskatchewan as a health district; and
- (b) assigning a name to the health district.

**4** Before an order is made pursuant to section 3, the minister shall carry out consultations in the manner and to the extent that the minister considers appropriate:

- (a) in the case of an order pursuant to subsection 3(2) or (3), within the area to be included in the proposed health district . . .

**5(1)** Subject to sections 9, 10 and 11, the Lieutenant Governor in Council may make an order establishing a district health board for a health district.

(2) A district health board is a corporation have the name "\_\_\_\_\_ District Health Board", the blank being filled in to correspond with the name of the health district.

(3) Subject to subsection (4) and clause 13(3)(e), a district health board shall consist of not more than 12 members.

**6(1)** The Lieutenant Governor in Council:

- (a) subject to subsection (2) and to subsections 9(3), 10(3) and 11(3), shall appoint the first members of each district health board; and
- (b) may make subsequent appointments of members to a district health board until the first election of members pursuant to section 7.

(2) No person is to be appointed as a member of a district health board pursuant to subsection (1) unless the person is nominated by a person who resides in the health district.

(4) Each member appointed pursuant to this section:

- (a) is appointed at pleasure; and
- (b) holds office:
  - (i) in accordance with subsection 7(1); or
  - (ii) where no election has been held pursuant to section 7, for the term specified in the order and thereafter until the member is reappointed or a successor is appointed.

(5) The Lieutenant Governor in Council may designate one of the members appointed to a district health board pursuant to this section who is a resident of the health district as chairperson and another member who is a resident of the health district as vice-chairperson.

**7(1)** The members of a district health board hold office until the first meeting of the district health board that is held after an election pursuant to this section.

(2) Subject to any regulations made pursuant to clause 40(1)(i) or (j), the residents of a health district shall elect eight members to the district health board in an election conducted in accordance with the regulations.

**2** The Minister of Health has carried out consultants within the area to be included in the proposed health district.

**3** The persons proposed as members of the district health board have been nominated by persons who reside in the proposed health district.

**4** It is desirable and in the public interest:

- (a) to establish the Lloydminster Health District;
- (b) to establish a district health board for the Lloydminster Health District; and
- (c) to appoint the first member of the Lloydminster District Health Board.

The undersigned has the honour, therefore, to recommend that Your Honour's Order do issue pursuant to sections 3, 5 and 6 of *The Health Districts Act*, effective the date this Order is published in *The Saskatchewan Gazette*:

(a) establishing a health district consisting of the area described below and assigning the name "Lloydminster Health District" to that area:

The Lloydminster Health District is bounded as follows: Commencing at the intersection of the west boundary of the province and the left bank of the North Saskatchewan River; thence southeasterly along the left bank of the North Saskatchewan River to the dividing line between ranges twenty-four and twenty-five, in township fifty-one, west of the third meridian; thence southerly along the said dividing line between ranges twenty-four and twenty-five to the north boundary of township forty-nine; thence westerly along the north boundary of township forty-nine, to the east boundary of section thirty-three, in township forty-nine, range twenty-six, west of the third meridian; thence southerly along the east boundary of sections thirty-three, twenty-eight, twenty-one, sixteen, nine and four, all in said township forty-nine, range twenty-six to the north boundary of township forty-eight; thence westerly along the north boundary of township forty-eight to the east corporate limit of the Village of Marshall; thence northerly, westerly and southerly along the east, northerly and westerly corporate limits of the Village of Marshall to the north boundary of township forty-eight; thence westerly along the north boundary of township forty-eight to the dividing line between ranges twenty-six and twenty-seven, west of the third meridian; thence southerly along the said dividing line between ranges twenty-six and twenty-seven to the north boundary of

township forty-six; thence easterly along the north boundary of township forty-six to the left bank of the Battle River; thence southwesterly along the left bank of the Battle River to the west boundary of the province; thence northerly along the west boundary of the province to the point of commencement.

(b) establishing the Lloydminster District Health Board for the Lloydminster Health District;

(c) appointing the following persons as the members of the Lloydminster District Health Board to serve at pleasure until the first meeting of the district health board that is held after an election pursuant to section 7 of *The Health Districts Act*:

(d) designated John Acton as chairperson of the Lloydminster District Health Board and E. Marie Long as vice-chairperson of the Lloydminster District Health Board.

### **RULES OF COURT**

#### COURT OF QUEEN'S BENCH

The Rules of the Court of Queen's Bench for Saskatchewan are amended, effective the 1st day of March, 1996, in the manner set out below.

There shall be added, following Rule 9, the following Rules:

#### **Filing of Documents by Fax**

**9A** In this Part, "telecopier" means a machine or device that electronically transmits a copy of a document, picture or other printed material by means of a telecommunication system.

**9A.1(1)** (a) Any document that may be issued or filed, and  
(b) any transaction that may be carried out, by means of mail under Rule 9 may be issued or filed or carried out by means of a telecopier in accordance with this Part.

(2) Notwithstanding Subrule (1), the local registrar may refuse to issue or file a document under this Part if in the opinion of the local registrar the document is of a type or has physical characteristics that are such that the document should not be issued or filed under this Part.

(3) Notwithstanding Subrule (1), the local registrar may refuse to issue or file a document under this Part for any lawyer who is in default of payment of any fees or charges payable to the local registrar.

**9A.2** Where the local registrar

(a) issues or files a document under this Part, and

(b) returns by telecopier or otherwise to the person who submitted the document for issuing or filing a true copy of that issued or filed document bearing a notation that the document was issued or filed by means of a telecopier, that copy of the issued or filed document is valid for the purposes of any Rule that refers to an original, true copy, certified copy or concurrent copy.

Rule 15 is repealed and the following substituted therefor:

**15(1)** Where the main office of a lawyer is not located at or within 15 kilometres of a judicial centre, an action may be commenced as follows:

(a) the lawyer may, by telephone, notify the local registrar at the judicial centre nearest to his main office, of the names in full of the parties to the action, the type of claim to be made, and such other information as may be required by the local registrar;

(b) the local registrar shall record the information in the procedure book and inform the lawyer of the court file number;

(c) the lawyer shall on the day the court file number is assigned endorse on the Statement of Claim, Originating Notice or Petition the court file number and a certificate that the Statement of Claim, Originating Notice or Petition was issued by telephone by the local registrar, and it shall on that date be deemed to be issued;

(d) the lawyer shall no later than the next day file with the local registrar, or mail to him by registered mail, the original Statement of Claim, Originating Notice or Petition together with the proper fee and any other documents required by these Rules for the commencement of a proceeding.

(2) (a) When the local registrar receives the Statement of Claim, Originating Notice or Petition, it shall be compared with the information recorded in the procedure book and if it is in conformity with the information in the procedure book, if it was filed or mailed as required, and all other documents required by these Rules to be filed at the time of the commencement of the proceeding were filed, he shall sign, seal and file it.

(b) If the Statement of Claim, Originating Notice or Petition does not conform to the information in the procedure book, was not filed or mailed as required and all other documents required by these Rules to be filed at the time of the commencement of the proceeding were not filed, the local registrar shall attach to the original document a memorandum to that effect, and notify the lawyer who filed the same, and no further step in the proceedings may be taken by the plaintiff without leave of the court.

(3) A local registrar may refuse to issue a Statement of Claim, Originating Notice or Petition under this Rule for any lawyer who is in default of payment of any fees or charges payable to the local registrar.

(4) A judge may at any time instruct the local registrar to refuse to issue Statements of Claim, Originating Notices or Petitions by telephone for a lawyer designated by the judge.

Subrule (3) of Rule 192 is repealed.

There shall be added, following Subrule 191(16), the following Subrule:

**191(17)** Where a pre-trial date has been assigned, the party having carriage of the proceeding shall forthwith pay the required fee for setting down.

There shall be added, following Rule 193, the following Rule:

**194** Where a trial date has been assigned by an order pursuant to Subrule 191(1), the party having the carriage of the proceeding shall forthwith pay the required fee for setting down.

#### VIII-B Variation Proceeding

**624B(1)** A party shall commence a variation proceeding under *The Children's Law Act* and *The Family Maintenance Act* by application in Form 73, and it shall be accompanied by an affidavit in support.

(2) The affidavit shall, with necessary modifications, comply with Rule 616.

(3) The provisions of Rule 614 respecting financial statements shall, with necessary modifications, apply.

(4) The length of notice of an application shall be in accordance with Rule 447

Form 73 is amended by deleting the title "Application for Variation of Corollary Relief" and substituting therefor "Application for Variation".
