## OTHER AREAS — SALT WATER DISPOSAL

MRO 6/99. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, MRO 720/98, dated November 24, 1998, is rescinded and approval is granted to Herc Oil Corp. to dispose of salt water recovered from oilfield production, by injection into the Mannville Formation through the well Herc Pinto 14-32-1-4, in accordance with plans and specifications filed with the Department as Document No. S.W.D. 684 and subject to the following:

1 Installations shall be subject to the approval of a field representative of the Department prior to the commencement of salt water injection and subsequent to any modifications to such installations.
