ALTERATION OF SUBDIVISION BOUNDARIES  
OF SCHOOL DIVISIONS

No. 050/2000 ED. Pursuant to the powers vested in me by subsections 54(1) and (3) of *The Education Act, 1995*, and in compliance with the provisions of clause 42(1)(e) and section 61 of the said Act, I hereby order, with respect to the Potashville School Division No. 80 of Saskatchewan, the following, effective September 1, 2000:

- 1 that sub-division No. 6 be disorganized;
- 2 that paragraph No. 5 of Minister's Order No. 76, dated December 1, 1978, and which was effective January 1, 1979, which established the said School Division, be amended in such a manner to state that the Board of Education of the said School Division shall consist of five (5) members;
