### ***The Clean Air Act***

#### **TOWN OF SOUTHEY — REFUSE BURNING BYLAW**

Notice is hereby given that the Town of Southey passed a Refuse Burning Bylaw on June 27, 2000 and it was subsequently approved by the Minister of Environment and Resource Management on July 18, 2000.

This bylaw regulates the burning of refuse within the boundaries of the Town of Southey. It prohibits the open burning of trash, refuse, garbage, industrial waste or any other material (ie: used oil) or waste in an open fire or an incinerator or stove in a manner that causes air pollution within the boundaries of the Town of Southey.

### ***The Medical Profession Act***

#### **COLLEGE OF PHYSICIANS AND SURGEONS — BYLAW AMENDMENT**

**Bylaw 21 is amended by repealing paragraphs 21(6)(k) through (p) inclusive and substituting the following:**

“(k) Until December 31, 2001, the Council shall register and issue a special licence under subsection 30(3) of the Act if the person produces evidence in a form and manner that may be acceptable to the Council that the person:

- (i) is of good character; and
- (ii) is of good standing as a practitioner; and
- (iii) is the person who is the subject of the request of the Minister under subsection 30(3) of the Act; and
- (iv) is to be engaged with the Saskatchewan Cancer Agency;

(v) has completed post-graduate training as evidenced by a specialty qualification acceptable to the Council.

“(l) A physician who is granted a special licence under paragraph (j) is required:

- (i) at the first opportunity to take an examination acceptable to the Council in that physician's specialty; and
- (ii) to pass the MCCEE and the MCCQE within a period of five years of the date of registration.

“(m) If the holder of a special licence granted under paragraph (j) does not successfully complete the examination in that physician's specialty acceptable to the Council at the first opportunity to take the examination, the Council may:

- (i) revoke that special licence; or
- (ii) grant the person one or more opportunities to take that examination, subject to such terms and conditions as the Council may determine.

“(n) If the holder of a special licence granted under paragraph (j) is granted one or more additional opportunities by the Council to successfully complete the examination in that physician's specialty acceptable to the Council in accordance with paragraph (f)(ii), the Council may revoke that person's special licence if that person:

- (i) does not successfully complete that examination; or
- (ii) does not comply with the terms and conditions imposed by the Council.

“(o) A special licence shall be automatically revoked and shall cease to be valid if:

- (i) the holder of the special licence ceases to practice in the community in which he/she applied to work, unless he/she has applied to the Council to practice in another community, and has satisfied the Council that his/her practice in that community complies with paragraph (b)(vi) or (d)(v) above; or
- (ii) the holder of the special licence ceases to be employed by or practice under contract with the employer for whom he/she applied to work, unless he/she has received the approval of the Council to work for another employer; or
- (iii) the holder of the special licence ceases to be engaged in the branch of the public service of Saskatchewan in a hospital, district health board, or other institution if the special licence was granted under paragraph (h), (i) or (j) above; or
- (iv) the holder of a special licence who has applied to work in a sub-specialty ceases to confine his or her practice to that sub-specialty; or
- (v) the holder of a special licence who has applied because of an academic appointment ceases to hold that academic appointment; or
- (vi) the holder of a special licence granted under paragraph (b) fails to obtain certification from the Royal College of Physicians and Surgeons of Canada within the period of eligibility with the Royal College of Physicians and Surgeons; or
- (vii) the holder of a special licence granted under paragraph (b) fails to become registered under section 28 within five years of the date of initial registration; or
- (viii) the holder of a special licence granted under paragraph (d) or (j) does not pass the MCCEE and the MCCQE within a period of five years after first registration with the College.

“(p) A person who signs a commitment to practice in a community in accordance with this section, and who, during the period of that commitment practices in a community other than the community to which the commitment applies, shall be guilty of unbecoming, improper, unprofessional or discreditable conduct.

“(q) Paragraph (p) does not apply if the person has received the permission of the Council to practice in the other community and practices in accordance with the terms of the permission given by the Council”.
