MINISTER'S ORDERS

The Oil and Gas Conservation Act

DEE VALLEY WASECA SAND POOL

MRO 148/01 PO 9. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 878/93 PO 65, dated December 23, 1993, is rescinded and the following provisions shall apply to the drilling of, and the production of oil and gas from, vertical oil wells in the Dee Valley Waseca Sand Pool, effective March 1, 2001:

1 The drainage unit shall be one legal subdivision with the exception of the area described in clause 2(a) where the drainage unit shall be the north half or the south half of a legal subdivision.

2 The target area shall be a square with 200 m sides located in the south-east corner of the drainage unit, with the exception of the following areas:

(a) For lands West of the Third Meridian:

In Township 49, Range 22: Legal subdivisions 5, 6, 11, 12, 13 and 14 of Section 6;

In Township 49, Range 23: the south-east quarter of Section 12:

(i) in the north drainage unit of the legal subdivision, the target area shall be a square with 100 m sides located 50 m from the north and west sides of the drainage unit;

(ii) in the south drainage unit of the legal subdivision, the target area shall be a square with 100 m sides located 50 m from the south and east sides of the drainage unit.

3 If a well is not completed within the target area, the minister may reduce the area used as a factor in determining the MARP.

4 Samples of drill cuttings from formations below the top of the Devonian System shall be taken and delivered to the Department.

5 Wells licensed prior to March 1, 2001, shall be considered to be completed within the target area.

CLARILAW FROBISHER-ALIDA BEDS — HORIZONTAL WELL PROJECT

MRO 149/01. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, approval is granted to Progress Energy Ltd. to drill and complete one horizontal well in the Frobisher-Alida Beds underlying legal subdivisions 7 and 8 of Section 21-7-5 W2M, in accordance with plans filed with Saskatchewan Energy and Mines as Document No. H.W. 915 and subject to the following:

1 A maximum allowable rate of production shall be assigned.

1 Good production practice is approved.

WINTER SOUTH MCLAREN SAND POOL — PILOT WATERFLOOD PROJECT

MRO 151/99. Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, approval is granted to Wascana Energy Inc. to construct the facilities and to recompleting the (91) 13-34-41-25 W3M well as a pressure maintenance water injection well, in accordance with plans filed with Saskatchewan Energy and Mines as Document No. P.M. 1368 and subject to the following:

1 Installations shall be subject to the approval of a field representative of the Department prior to the commencement of water injection and subsequent to any modifications to such installations.

2 The wellhead injection pressure shall be limited to a maximum of 7 000 kilopascals (kPa).

1 Bylaw II, Section 2(5) is amended by adding new clauses 5.1 and 5.2 as follows:

“5.1 Persons eligible for a licence to practice under subsection 5 must also have:

(a) worked at least 1,200 practice hours as set out in Schedule “B” to these Bylaws, within the five-year period immediately preceding the date of application for the year in which the licence is sought; and

(b) completed 2.0 continuing education credits in accordance with the requirements of the Professional Improvement Program, as approved by the Council from time to time, within the five-year period immediately preceding the date of application for the year in which the licence is sought”.

“5.2 Clause 5.1 does not apply to applicants for a licence who have met the requirements of Bylaw II, Section 2, Subsection (1) or (2) within the five-year period immediately preceding the date of application for the year in which the licence is sought”.

2 Bylaw II, Section 2(8)(d) is repealed and replaced by the following:

“Persons practicing on a temporary licence must meet the requirements of Bylaw II, Section 2, Subsection (1)(c) within fourteen (14) months after completion of an educational program for medical laboratory technologists as approved by the Council”.

3 Bylaw II, Section 2 is amended by adding a new Subsection (9) as follows:

“A temporary licence to practice may be issued to a person who does not meet the requirements of Clause 5.1”.

“Candidates who fail the examinations on the first writing are required to rewrite at the next examination unless postponement is allowed by the Executive Director due to exceptional circumstances. Candidates must meet the eligibility requirements for each writing and must complete the necessary application and pay the prescribed fee therefore”.

7 Schedule B, Section 3 is repealed and replaced by the following:

“New graduate medical laboratory technologists shall have five years to obtain the 1,200 practice hours and to complete the 2.0 continuing education credits in accordance with the requirements of the Professional Improvement Program to maintain their eligibility to practice”.

8 Schedule B, Section 5(b) is repealed and replaced by the following:

“Volunteer hours obtained in the practice of medical laboratory technology may be used to achieve the required number of practice hours. Volunteer hours must be documented on the appropriate form and evaluated by the Credentials Committee”.

9 Schedule B, Section 5(j) is repealed and replaced by the following:

“Medical laboratory technologists who work solely in industrial laboratories shall be required to obtain the equivalent of 240 practice hours through the completion of CSMLS/SSMLT recognized continuing education programs in the general medical laboratory technology disciplines plus a minimum of 960 actual hours worked in an industrial laboratory in the five-year period immediately preceding the date of application for the year in which the licence is sought”.

(ii) The registrant must obtain the LMCC within a period of 3 years of the date of registration if a family physician, and 5 years from the date of registration if a specialist, if the physician has passed the MCCEE at the time of registration; and

(iii) The registrant must pass the MCCEE within 2 years of the date of registration, if the physician has not passed the MCCEE; and

(iv) The registrant must pass the MCCQE Part I within 4 years of the date of registration, if the physician has not passed the MCCEE at the date of registration; and

(v) The registrant must obtain the LMCC within 5 years of the date of registration, if the physician has not passed the MCCEE at the date of registration;

(vi) The registrant will provide to the College full documentation respecting any examination results from the Medical Council of Canada or the Royal College of Physicians and Surgeons of Canada;

(vii) If the results achieved by a registrant in an examination from the Medical Council of Canada are, in the opinion of the Council, a substantial departure from what is to be expected of a physician practicing medicine in Saskatchewan, the Council may revoke a provisional licence granted to the registrant, or may impose additional conditions in respect of that registrant's medical practice;

(viii) If an applicant has previously failed any examination of the Medical Council of Canada, the time periods set out in paragraphs (i) to (v) above may be reduced;

(ix) Where in the opinion of the Council extraordinary circumstances exist relating to a registrant, the Council may extend the time for a registrant to challenge or complete any of the examinations referred to above;

(x) The registrant must practice in the community for which they are registered for three years, and can only move before that time with the permission of Council".

(4) Deleting the words "five-year commitment" where they appear in paragraphs 21(6)(a)(ix) and 21(6)(d)(vii) and substituting the words "three-year commitment".

(5) Deleting the words "has signed a commitment to practice in the community for which the person is registered for a period of five years and" where they appear in paragraph 21(6)(h)(iii).

(6) Deleting the word "and" where it appears at the end of paragraph 21(6)(i)(vi) and deleting paragraph 21(6)(i)(vii).

(7) Deleting the word "and" where it appears at the end of paragraph 21(6)(j)(vi) and deleting paragraph 21(6)(j)(vii).

(8) Deleting paragraphs 21(9)(i) through (l) inclusive.

(9) Renumbering paragraphs 21(9)(m) through (p) as 21(9)(i) through (l) respectively.

(10) Deleting paragraph 21(11)(b) and substituting the following:

"(b) Any action or decision that, pursuant to paragraph 21 of these bylaws, to be taken or made by the Council may be taken or made by the Registrar, or a member of the Registrar's staff;

(c) The Council delegates to the Registrar and the members of the Registrar's staff its authority to issue licences and permits, and to take actions and make decisions to the extent required to give effect to paragraphs 11(a) and (b) above".
