The Education Act, 1995 [subsection 54(1), sections 118 and 357]

ALTERATION OF SCHOOL DIVISION BOUNDARIES

No. 011/2001. Pursuant to the powers vested in me by subsection 54(1) of *The Education Act, 1995*, and in compliance with section 357 of the said Act, I hereby order that the boundaries of the following school divisions be altered, effective June 1, 2001, in the manner set forth herein:

Sub-division No. 2 of the Weyburn Central School Division No. 73 of Saskatchewan —

Adding thereto:

In Township 10, Range 9, West of the Second Meridian: the southeast quarter of the section 27;

Sub-division No. 10 of the Souris Moose Mountain School Division No. 122 of Saskatchewan —

Taking therefrom:

In Township 10, Range 9, West of the Second meridian: the southeast quarter of section 27.

I further order, pursuant to section 118 of *The Education Act, 1995*, that the education portion of any tax arrears on the aforementioned land shall be payable to the Board of Education of the Souris Moose Mountain School Division No. 122 of Saskatchewan and further, that the education portion of taxes owing or already paid for the current year shall be apportioned between the said two school divisions in a manner mutually agreed upon by the respective boards of education.

BURSTALL MILK RIVER GAS POOL BURSTALL MEDICINE HAT SAND GAS POOL BURSTALL MILK RIVER-MEDICINE HAT GAS POOL

MRO 321/01 PB 16. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 601/00 PB 50, dated July 6, 2000, is rescinded and the following area is designated and identified as gas pools named the "Burstall Milk River Gas Pool", "Burstall Medicine Hat Sand Gas Pool" and "Burstall Milk River-Medicine Hat Gas Pool", effective May 1, 2001:

Lands West of the Third Meridian:

In Township 19, Range 27: Sections 1 to 18;

In Township 19, Range 28: Sections 1 to 24 and 28 to 33;

In Township 20, Range 28: Sections 5 to 7;

In Township 19, Range 29: Sections 1 to 5, fractional Sections 6 and 7, Sections 8 to 17, fractional Sections 18 and 19, Sections 20 to 29, fractional Sections 30 and 31, and Sections 32 to 36;

In Township 20, Range 29: Sections 1 to 5 and fractional Section 6.

MRO 322/01 PO 19. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 600/00 PO 47, dated July 6, 2000, is rescinded and the pool provisions in the following schedule shall apply to the drilling of, and production from, gas wells in the Burstall Milk River Gas Pool, Burstall Medicine Hat Sand Gas Pool and Burstall Milk River-Medicine Hat Gas Pool, effective May 1, 2001.

Dated at Regina, Saskatchewan, May 11, 2001.

Schedule

1 The drainage unit for the drilling and completion of a gas well shall be two legal subdivisions in a Section grouped as follows:

Legal subdivisions 1 and 2; 3 and 4; 5 and 6; 7 and 8; 9 and 10; 11 and 12; 13 and 14; 15 and 16;

with the exception of the following drainage units which shall be:

(a) the fractional quarter Section containing approximately 36 hectares within the area described in clause 2(a);

2 Within a drainage unit, the target area shall be a 235 m square situated in the north-east corner of legal subdivisions 2, 4, 6, 8, 10, 12, 14 and 16, with the exception of the following:

(a) the target area shall be a 235 m square situated in the north-east corner of legal subdivisions 8 and 16 within the following lands West of the Third Meridian:

In Township 19, Range 29: fractional Sections 6, 7, 18, 19, 30 and 31;

In Township 20, Range 29: fractional Section 6;

(b) no wells shall be drilled within 300 m of the south boundary of the following lands West of the Third Meridian:

In Township 19, Range 28: Sections 3 to 6;

In Township 19, Range 29: Sections 1 to 5;

(c) no wells shall be drilled within 300 m of the west boundary of the following lands West of the Third Meridian:

In Township 20, Range 28: Section 7;

(d) the approval of the Rural Municipality shall be obtained prior to drilling a well closer than 75 m to a road allowance, but no wells shall be drilled within 35 m of a road allowance.

3 All gas wells drilled to or completed in this pool prior to May 1, 2001, shall be considered to be drilled on-target as prescribed in section 2.

4 Unless otherwise ordered by the minister, every well shall be flow tested within 3 months after commencement of production in a manner approved by the minister and any such flow tests may be made in lieu of subsections 73(1) and (2) of *The Oil and Gas Conservation Regulations, 1985*.

5 The operator shall have the following logs as a minimum requirement for gas wells drilled to this pool:

(a) for at least one well per Section, an approved resistivity log or standard electric log shall be run;

(b) an approved pulsed neutron capture log may be substituted for the requirements of clause 5(a);
