ORDERS IN COUNCIL/DÉCRETS

The Provincial Lands Act

[O.C. 741/2003]

24 September 2003

TO THE HONOURABLE
THE LIEUTENANT GOVERNOR IN COUNCIL

The undersigned has the honour to report that:

1 Section 22.1 of *The Provincial Lands Act*, provides, in part, as follows:

22.1(1) The Lieutenant Governor in Council may make orders:

(a) prescribing matters or things that are, in the opinion of the Lieutenant Governor in Council, necessary to meet the purposes and intent of this Act, to carry out the agreement of transfer or to meet cases that may arise and for which no provision is made in this Act;...

(2) Subject to other provisions of this Act, an order made pursuant to this section comes into force:

- (a) only after it has been published in the Gazette; or
- (b) after a date named in the order;

whichever is the later.

2 Under section 6.02 of the Cowessess Treaty Land Entitlement Settlement Agreement, dated March 14, 1996, Saskatchewan agreed to give favourable consideration to offers from the Band to purchase the land forming the bed and shore of a water body adjacent to Entitlement Land.

3 Clause 80(b) of *The Saskatchewan Watershed Authority Act* permits Saskatchewan to transfer to Her Majesty the Queen in right of Canada the land forming the bed and shore of a water body that is adjacent to an Indian Reserve that has been set apart pursuant to the terms of a Framework Agreement.

4 The Cowessess Treaty Land Entitlement Settlement Agreement is a Framework Agreement within the meaning of *The Saskatchewan Watershed Authority Act*.

5 The land described in Schedule "A" is provincial land consisting of the bed and shore of a water body adjacent to Entitlement Land, which Entitlement Land has been purchased by the Cowessess First Nation pursuant to the terms of the Settlement Agreement.

6 The Cowessess First Nation has offered to purchase the land described in Schedule "A" for \$1.00, and Saskatchewan is prepared to transfer the land to Her Majesty the Queen in right of Canada pursuant to clause 80(b) of *The Saskatchewan Watershed Authority Act* and section 22.1 of *The Provincial Lands Act*.

7 It is desirable and in the public interest to make an order transferring the administration and control of the land described in the attached Schedule "A" to Her Majesty the Queen in right of Canada for the purpose of the setting apart of a Reserve for the use and benefit of the Cowessess First Nation under the terms of the Settlement Agreement.

The undersigned has the honour, therefore, to recommend that Your Honour's Order do issue, pursuant to section 22.1 of *The Provincial Lands Act*, transferring the administration and control of the land described in the attached Schedule "A" to Her Majesty the Queen in right of Canada, for the sum of one dollar (\$1.00), such transfer to be effective on the day that the said land is set apart by the Governor General in Council as a Reserve for the use and benefit of the Cowessess First Nation.

Adding thereto:

In Township 40, Range 27, West of the Second Meridian: the south half of section 6;

Sub-division No. 2 of the Wakaw School Division No. 48 of Saskatchewan —

In Township 40, Range 27, West of the Second Meridian: the south half of section 6.

GRANTING THE REQUEST FOR A MUNICIPAL RESTRUCTURING BETWEEN THE RURAL MUNICIPALITY OF KUTAWA NO. 278 AND THE RURAL MUNICIPALITY OF MOUNT HOPE NO. 279

Pursuant to section 13.3 of *The Rural Municipality Act, 1989*, the Rural Municipality of Kutawa No. 278 and the Rural Municipality of Mount Hope No. 279 have negotiated a municipal restructuring agreement that will dissolve each rural municipality and incorporate a new rural municipality named the Rural Municipality of Mount Hope No. 279. The rural municipalities have finalized the agreement and presented it to the Minister of Government Relations for approval. Upon review of the agreement, it is deemed appropriate and in the public interest to approve the request of the rural municipalities and order the incorporation of a new rural municipality.

Pursuant to clause 13.3(4)(a) of *The Rural Municipality Act, 1989*, the terms and conditions of the municipal restructuring agreement entered into by the Rural Municipality of Kutawa No. 278 and the Rural Municipality of Mount Hope No. 279 are as follows:

1 Effective January 1, 2004, both parties to this agreement wish to restructure to form one new Rural Municipality which shall be called the Rural Municipality of Mount Hope No. 279.

2 The new Rural Municipality of Mount Hope No. 279 shall be divided into six divisions and its council shall consist of a Reeve and six councillors.

3 With the exception of clause 6 of this agreement, the council of the new Rural Municipality of Mount Hope No. 279 is hereby authorized to amend this agreement at any time.

4 All the assets, liabilities and contractual obligations of the parties to this agreement shall become those of the new Rural Municipality of Mount Hope No. 279.

5 The imposition of special levies is not necessary for the purpose of equalizing municipal mill rates, renewing municipal infrastructure and/or remedying and reclaiming contaminated sites.

6 All taxable assessed properties within the boundaries of the Rural Municipality of Kutawa No. 278 shall be subject to a special levy of one mill during the year 2004 for the purpose of retiring a long term debt.

7 A uniform municipal tax mill rate and special fire protection tax mill rate shall be determined by the council of the new Rural Municipality of Mount Hope No. 279.

8 All conditional and unconditional grants due to either party to this agreement on December 31, 2003, shall be paid to the new Rural Municipality of Mount Hope No. 279.

9 All surplus funds and reserves of either party to this agreement shall become the surplus funds and reserves of the new Rural Municipality of Mount Hope No. 279.

10 With regard to the application of tax tools, as prescribed by *The Rural Municipality Act, 1989*, both parties agree that a 1.29 mill rate factor shall apply to the uniform municipal and special levy tax rates applied to commercial and industrial assessments in the new Rural Municipality of Mount Hope No. 279.

11 The municipal office for the new Rural Municipality of Mount Hope No. 279 shall be located in the office presently being used by the Rural Municipality of Mount Hope No. 279 which is located in the Village of Semans.

12 The Rural Municipality of Mount Hope No. 279 Administrator, Jim Down, and Assistant, Sandra Down, shall continue on as Administrator and Assistant of the new Rural Municipality of Mount Hope No. 279.

13 The Rural Municipality of Mount Hope No. 279 Road Foreman, Dave Code, shall continue on as Road Foreman of the new Rural Municipality of Mount Hope No. 279.

14 All Rural Municipality of Kutawa No. 278 and Rural Municipality of Mount Hope No. 279 road crew members shall be eligible to be rehired in 2004.
