APPOINTMENT OF JUDGES TO SOLEMNIZE MARRIAGES

O.C. 668/43. June 22, 1943. Approved and Ordered. Lieutenant Governor.

The Executive Council has had under consideration a report from the Minister of Public Health, dated June 21, 1943, stating that it is expedient to appoint all Judges of the District Courts of the Province of Saskatchewan as Marriage Commissioners.

The Minister further states that O.C. 1037/36, dated the 15th day of September, 1936, and O.C. 990/40, dated the 16th day of August, 1940, provide for the appointment of all Judges of the District Courts of the Province of Saskatchewan as Commissioners to solemnize marriages, such appointments to take effect as on, from and after the first day of October, 1936, and to take effect as on, from and after the first day of August, 1940, respectively.

Upon consideration of the foregoing report and on the recommendation of the Minister of Public Health, the Executive Council advises under the provisions of section 9 (d) of The Marriage Act, that the approval of His Honour the Lieutenant Governor do issue approving the appointing of all Judges of the District Courts of the Province of Saskatchewan appointed on, from and after the first day of October, 1936, as District Court Judges, or who may hereafter be appointed as District Court Judges, as Commissioners to solemnize marriages; the said appointment to solemnize marriages to take effect as on, from and after their appointment as Judges of the District Courts of the Province of Saskatchewan.
