1 That from and after the effective date of this order, every producer of pulses shall pay to the Board a check-off of 1.0% plus GST of the gross sale price of all pulses.

2 Every buyer, processor, broker, assembler, exporter or marketer who acquires pulses from a producer shall deduct the amount of the check-off plus GST from any payment made to producers for those pulses and shall forward such check-off to the Board or the Board’s designate.

3 A buyer, processor, broker, assembler, exporter, marketer who forwards a check-off to the Board pursuant to paragraph 2 shall forward to the Board with the check-off a report, in a format and by a process approved by the Board, setting out, for each purchase for which a check-off is made, the producer’s full name, (including last name and first name), mailing address (including city, province and postal code), Canadian Wheat Board number, telephone number, e-mail address, Gross Price of Purchase, Total Deduction (Check-off + GST) and Crop type, no later than the 30th day of the month following the month in which the pulses were purchased.

4 Order 11/03: Check-off Collection is hereby wholly revoked.

5 This order will remain in effect for a period of five years, at which time it will be reviewed.

THE COMMERCIAL EGG MARKETING
PLAN REGULATIONS — EGGS FOR PROCESSING ORDER

The Saskatchewan Egg Producers, pursuant to *The Agri-Food Act, 2004*, *The Agri-Food Regulations, 2004* and *The Commercial Egg Marketing Plan Regulations*, hereby determines and orders that:

This Order No. 38/05, being an order governing the production, marketing and pricing of eggs for processing in Saskatchewan, shall be referred to as the *Eggs for Processing Order*.

1 In this Order:

(a) “**EFP eggs**” means eggs produced for the processing market as contemplated by the allocation to Saskatchewan by the Canadian Egg Marketing Agency of eggs for processing quota;

(b) “**EFP layers**” means layers which produce EFP eggs;

(c) “**EFP licence**” means a licence granted by the SEP to a producer authorizing the placement of EFP layers and the production and marketing of EFP eggs;

(d) “**EFP producer**” means a producer who holds a valid EFP licence;

(e) “**Production cycle**” means a period of one year beginning when EFP layers are placed in a production unit pursuant to an EFP licence;

(f) “**Production**” means the number of dozens of eggs produced by one or more layers. “EFP production” means the number of dozens of eggs produced by one or more EFP layers.

2 No person, corporation or entity may place EFP layers or produce EFP eggs without a valid EFP licence.

3 The SEP may award an EFP licence to a registered producer who holds a valid licence and who applies to the SEP for an EFP licence using the form prescribed for that purpose by the SEP.

4 Applications for an EFP licence may be made to the SEP at any time during the calendar year using the form entitled “EFP Licence Application or EFP Licence Amendment Application” (EFP Application). Using the EFP Application, an EFP producer may apply to the SEP, at any time in a production cycle, to amend the terms of its EFP Licence previously granted by the SEP to increase the number of EFP layers or to reduce all or part of the number of EFP layers (the “adjustment”). The EFP Application must be delivered to the SEP Office at least 10 days prior to the date that an intended adjustment is to take place, except in the case of a downward adjustment to the number of EFP layers that is to convert into new commercial production relating to a new or additional production limit allotted to the producer – in this case, the downward adjustment will take effect on the first day of the full CEMA week following the date of notification.

5 The required period of 10 days for advance notification of an adjustment may be waived by the SEP, in its absolute discretion.

6 The adjustment may only proceed upon receiving approval in writing from the SEP, subject to the following:

(a) All adjustments to the size of an EFP flock may only be initiated at the start of a CEMA week;

(b) Following an adjustment, the SEP will inventory the producer's total flock, including all commercial and EFP layers, except in the case of a free-run flock, in which case an inspector of the SEP must be present at the date and time of the adjustment in order to verify the change in EFP layer numbers;

(c) In the event that an EFP producer initiates two or more adjustments in a calendar year, the EFP producer will be responsible for all costs of the second and subsequent inspections.

7 The SEP will issue a revised EFP licence stating the amended EFP issuance as of the date of the adjustment approved by the SEP, effective for the remainder of the producer's EFP production year.

8 In the event of exceptional mortality, an EFP producer may apply in writing to the SEP for relief, stating the cause and relief sought. The application must be submitted within fifteen (15) business days of the date of the event. Every application for relief shall be considered by the SEP in its absolute discretion on a case by case basis.

9 The fee for an EFP Application is set at \$20.00.

10 The total number of EFP layers authorized by the SEP for placement pursuant to EFP licences shall not exceed the total EFP quota allocation made by the Canadian Egg Marketing Agency to Saskatchewan which is then in place.

11 An EFP licence shall:

(a) authorize the licence holder to place EFP layers and produce EFP eggs for a production cycle;

(b) require the licence holder to begin the production cycle within one year of receiving the licence;

(c) authorize the licence holder to have EFP layers and produce EFP eggs for any period or periods of time within the production cycle; and

(d) require that the EFP layers be located in a production unit owned by the licence holder.

12 EFP licences shall not be sold, leased or otherwise transferred.

13 The SEP may set policies and procedures in relation to any aspect of the regulation and control of the production and marketing of EFP eggs and, without limiting the generality of that authority, the SEP may set policies and procedures concerning:

(a) the placement of EFP layers;

(b) the production, pricing, handling and disposition of EFP eggs;

(c) the control and management of production units where EFP layers are located; and

(d) the reporting of EFP layer placements and EFP egg production.

14 EFP production will be calculated by the SEP each week for each EFP producer as the product of the EFP producer's EFP layer issuance according to the EFP producer's licence, and the CEMA COP Rate of Lay (ROL). Each week the SEP will assess the EFP production of each EFP producer against the total production of that EFP producer, including production from both the EFP layers and the commercial layers – the commercial production will be the production remaining (the "commercial remainder") from the total production after the EFP production is assessed or subtracted. The EFP producer will receive the EFP price for that EFP production each week, and the minimum commercial price on the commercial remainder. This data will be recorded weekly by the SEP on a weekly Payment Statement that will be issued to each EFP producer. Each EFP producer will have ninety (90) days from date of payment to report any inconsistency or error in the Payment Statement.

15 The total EFP production of each EFP producer will be calculated for each 52-week EFP production year after the 52-week production year is concluded. From those EFP producers exceeding the minimum average production level of the CEMA COP ROL for all EFP production, full commercial levies will be assessed on all production in excess of the minimum production level of the CEMA COP ROL for all EFP layers.

16 EFP production and shipments to processors from all sources over each calendar year must at least equal the product of the number of Saskatchewan EFP layers issued by licence and the CEMA COP ROL.

17 A producer who places EFP layers in excess of the number authorized by an EFP licence or places EFP layers without an EFP licence shall pay a penalty set at \$2 per bird per week. Interest is payable on overdue penalties at a rate that the SEP may set from time to time.

18 The SEP may set the minimum price(s) to be paid to producers for any or all grades of EFP eggs.

19 The SEP shall provide notice to registered producers of the following matters:

(a) changes to policies and procedures relating to the production and marketing of EFP eggs;

(b) opportunities to place EFP layers.

20 The SEP, at its discretion, may cancel or suspend an EFP licence if an EFP producer fails to comply with this Order or with any policies and procedures established by the SEP in relation to EFP production. The SEP shall give an EFP producer an opportunity to be heard at least 15 days before any such cancellation or suspension.

21 If the SEP is of the opinion that it is in the public interest to immediately suspend or cancel an EFP licence, the SEP may immediately suspend or cancel the licence and, on the suspension or cancellation, shall give the holder of the licence:

(a) written notice of the suspension or cancellation; and

(b) an opportunity to be heard within 15 days after the date of the suspension or cancellation.

EXTRACTS FROM THE RULES AND PROCEDURES OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN RELATIVE TO PRIVATE BILLS

PETITIONS

14(1) A petition to the Assembly may be presented by a Member at any time during the sitting of the Assembly by filing the same with the Clerk of the Assembly.

14(6) Petitions may be either written or printed; provided always that when there are 3 or more petitioners, the signatures of at least 3 petitioners shall be subscribed on the sheet containing the prayer of the petition.

14(9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE: *A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.*

PRIVATE BILLS

75(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.

75(2) No petition for any Private Bill shall be received by the Assembly if presented after the first twenty-five sitting days of the Session.

75(3) No Private Bill may be introduced in the Assembly after the first thirty sitting days of the Session.

76(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly, along with the petition for same, 2 copies of the bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of two hundred and fifty dollars, if the said bill does not exceed ten pages, and fifteen dollars additional for each page over that number; four hundred and fifty words shall be held to constitute a page.

76(2) In the case of a bill incorporating a company, a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk of the Assembly.

77 No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the committee charged with its consideration, or unless the bill has been withdrawn, rejected or not reported upon, in which cases the actual expenses incurred shall be deducted from the deposit received before making such remittance.

79(1) All petitions to the Legislature for Private Bills of any nature whatsoever, shall require a notice, clearly and distinctly specifying the nature and object of the application, and where the same refers to any proposed work, indicating generally the location of the work, and signed by and on behalf of the petitioners, with the address of the party signing the same; and when the petition is for an act of incorporation, the name of the proposed company shall be stated in the notice.

79(2) Such notice shall be published prior to the filing of the petition with the Clerk of the Assembly as required in Rule 75(1) in 2 consecutive issues of *The Saskatchewan Gazette* and 4 consecutive issues of a newspaper, published in English and having circulation in the locality affected.

79(3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the petition and bill.

80(2) Every bill for an act of incorporation, where a form of model bill has been adopted, shall be drawn in accordance with such model bill, copies of which may be obtained from the Clerk of the Assembly. Any provisions contained in any such bill which are not in accord with the model bill shall be inserted between brackets and shall be so printed.

83 When any bill for confirming any agreement is filed with the Clerk of the Assembly, a true copy of such agreement must be attached to it.

COMMITTEE RULING

In cases where the proposed bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the intent of the provisions of the proposed bill which provide for the exemption from taxation.

The name of the Member who is to present the petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the petition. Such Member should not, of course, be a Member of the Cabinet.
