ORDER IN COUNCIL/DÉCRET

The Provincial Lands Act

[O.C. 794/2007]
2 October 2007

TO THE HONOURABLE
THE LIEUTENANT GOVERNOR IN COUNCIL

The undersigned has the honour to report that:

1 Section 3 of *The Forest Resources Management Regulations* provides, in part, as follows:

3(2) The minister may withdraw land from a provincial forest with the written approval of the Lieutenant Governor in Council.

(3) Where land is withdrawn from a provincial forest by the minister:

(a) the written approval of the Lieutenant Governor in Council and the reasons for withdrawing the land are to be published in the Gazette; and

(b) the areas described in Part III are deemed to be amended accordingly.

2 Section 27 of *The Provincial Lands Act* provides, in part, as follows:

27(1) Subject to this Act and any applicable regulations, the minister may sell provincial lands on any terms and conditions that:

(a) the minister considers appropriate; and

(b) are not inconsistent with any terms and conditions that are prescribed in the regulations.

3 Section 4 of *The Crown Resource Land Regulations* provides, in part, as follows:

4(1) Subject to the approval of the Lieutenant Governor in Council, the minister may sell Crown resource land in accordance with this section if the Crown resource land is not part of a provincial forest.

4 All requirements of *The Crown Resource Land Regulations* and all other relevant laws, regulations and agreements in force have been fulfilled.

5 It is advisable and in the public interest to withdraw from the "Northern Provincial Forest" the land identified below which is required for commercial purposes.

6 It is advisable and in the public interest to sell the provincial land identified below to Larry Benning for commercial purposes for the total price of \$2,500.00 and to complete the necessary documents for title transfer.

The undersigned has the honour, therefore, to recommend that Your Honour's Order do issue:

(a) pursuant to section 3 of *The Forest Resources Management Regulations*, approving the withdrawal by the Minister of Environment of the land identified below from the "Northern Provincial Forest"; and

(b) pursuant to section 4 of *The Crown Resource Land Regulations*, approving the sale by the Minister of Environment of the provincial land identified below for commercial purposes to Larry Benning for the total price of \$2,500.00:

ORDER FOR INCREASING WEIGHT DESIGNATION
ON PROVINCIAL HIGHWAYS

Reference: Increasing weight limits on sections of Provincial Highway Nos. 15, 22, 30, 31, 33, 38, 42, 43, 44, 47, 48, 49, 310, 361 and 363.

For the purpose of managing traffic on and protecting provincial highways, NOTICE IS HEREBY GIVEN that effective 12:01 AM, October 5, 2007 unless restricted by a Minister's Order issued under clause 35.1(1)(a) of *The Highways and Transportation Act, 1997*, this Order authorizes any person, vehicle or class of vehicles to operate at the weights set for primary highways by *The Vehicle Weight and Dimension Regulations, 1999*, on provincial highways listed in the attached "Schedule A" to this Order, with the exception of April, May and June of each year.

This Order will remain in effect until March 31, 2010 unless sooner varied or rescinded.
