THE SASKATCHEWAN CHICKEN MARKETING PLAN REGULATIONS, 1978 — BASE QUOTA LEASING

ORDER NO. 37/07. The Chicken Farmers of Saskatchewan, pursuant to the provisions of *The Saskatchewan Chicken Marketing Plan Regulations, 1978*, and *The Agri-Food Act, 2004*, hereby determines and orders as follows:

- 1 The Board may allow a registered producer to lease all or part of that registered producer's quota to:
 - (a) another registered producer; or
 - (b) a person who is licensed as a lessee of quota.
- 2 No subleasing of quota shall be permitted.
- 3 An application to lease must be made on the basis of kilograms of quota to be produced in a given production period.
- 4 An application to lease quota must:
 - (a) be made in writing to the Board by the registered producer;
 - (b) be endorsed by the proposed lessee; and
 - (c) include any other information that the Board requires.
- 5 If an authorization to lease is granted by the Board, the Board may make the authorization subject to those terms or conditions that the Board considers appropriate in the circumstances.
- 6 All persons producing pursuant to a lease are subject to these regulations as if they were a registered producer.
- 7 The registered producer and lessee are:
 - (a) jointly responsible for reducing the marketing of chicken in accordance with these regulations;

(b) jointly and severally liable for:

- (i) all service charges assessed pursuant to these regulations;
- (ii) all levies assessed pursuant to these regulations; and
- (iii) any judgement obtained in respect of service charges or levies assessed pursuant to this regulation.

8 If a lease is terminated and any reduction in the marketing of chicken imposed pursuant to these regulations are not completed, the remaining reductions in the marketing of chicken are the responsibility of:

- (a) the registered producer who leased the quota to the lessee, if the lessee was not a registered producer; or
- (b) the lessee, if the lessee was a registered producer.

9 The Board shall not allow a lease of quota from a registered producer to a lessee if:

- (a) the registered producer has outstanding service charges or levies payable to the Board;
- (b) the proposed lessee would exceed the quota limit established by these regulations.

10 A lessee of quota who is not a registered producer shall not have rights afforded to registered producers confirmed pursuant to the Plan.

11 Order No. 09/00 – Base Quota Leasing, of the Chicken Farmers of Saskatchewan is hereby wholly revoked.

12 This Order will remain in effect for a period no longer than 10 years beyond the date this Order is approved by the Council.

 - (b) a check-off of \$0.0025 per kilogram of live chicken marketed on all quota classifications not mentioned in clause (a) shall be established.

4 The check-off collected in accordance with section 3 of this order is to be distributed in accordance with section 38 of the Plan.

5 All buyers who:

- (a) purchase chicken from a producer; or
- (b) acquire chicken from a producer for sale on the producer's behalf;

shall deduct the amount of the check-off from any proceeds payable to or on behalf of the producer.

6 Each buyer of chicken shall forward to the office of the board such check-offs along with a statement on a form provided by the board, setting out the following:

- (a) the amount of chicken obtained from the producer;
- (b) the amount of check-off being paid on behalf of the producer; and
- (c) the name and address of the producer.

7 Order No. 27/02 is hereby wholly revoked.

8 This order will remain in effect for a period no longer than 10 years beyond the date this order is approved by the Council.
