VILLAGE OF KENNEDY — BYLAW NO. 1-2010

**A Bylaw of the Village of Kennedy to regulate the burning of refuse within the boundaries of the Village of Kennedy.**

**The Council of the Village of Kennedy in the Province of Saskatchewan, under the authority of the Saskatchewan *Clean Air Act*, section 18, hereby enacts as follows:**

**DEFINITIONS:**

**1** All terms and expressions used in this Bylaw shall have the same respective meaning as in sections 2 and 18 of *The Clean Air Act* and section 11 of *The Clean Air Regulations*.

**PROHIBITION BURNING:**

**2** No person shall cause or permit to be caused the open burning of trash, refuse, garbage, industrial waste or any other material or waste in an open fire or an incinerator in a manner that causes air pollution within the boundaries of the Village of Kennedy.

**INCINERATORS:**

**3** No person shall cause or permit to be caused the burning of trash, refuse, garbage, industrial waste or any other waste material in a manner or in an incinerator other than that approved by the Ministry of Environment.

**EXCLUSIONS:**

**4** Sections 2 and 3 of this Bylaw do not apply to:

- (a) a camp fire or outdoor fireplace used for recreational purposes;
- (b) an outdoor fire using charcoal, processed coal or coke for cooking purposes;
- (c) the burning of brush for the purpose of clearing land for cultivation or for a road way, or any other right-of-way;
- (d) a fire for the purpose of burning weeds, the prevention or control of fires or the training of persons for fire fighting, if the fire is specifically authorized or required pursuant to any Act of Parliament or Bylaw of a municipality.

**5** Approval from the Council of the Village of Kennedy is required prior to causing a fire for the purposes outlined in clauses 4(c) and 4(d). In an emergency situation, approval may be obtained from the local fire or police authorities.

**PENALTIES**

**6** Any person who violates or fails to comply with any of the provisions of this bylaw is guilty of an offense and liable on summary conviction to the penalties set out in *The Municipalities Act* or the General Penalty Bylaw of the municipality.

**7** This Bylaw shall not come into force until thirty days after the date of publication of this bylaw in *The Saskatchewan Gazette*.
