  - (i) A member who intends to use surface electromyography shall apply to the board providing evidence of having successfully passed a Canadian Memorial Chiropractic College post graduate course, or its equivalent, in surface electromyography, recognized by the board.

# "8 Needle Insertion Acupuncture

(i) A member who intends to use acupuncture in their practice shall provide evidence to the board of successful completion of specific acupuncture training as taught in the core curriculum, post-graduate curriculum or continuing education division of one or more colleges accredited by the Council on Chiropractic Education (Canada), or in an accredited Canadian or American college/university or in an accredited school of acupuncture, and meet any additional requirements for continued competency that the board deems appropriate.

#### "9 Low-Level Laser

(i) A member who intends to use low-level laser must comply with sections 25 to 28 inclusive of *The Radiation Health and Safety Regulations*, 2005".

# Appendix Part 1, Article 1, Duties and Obligations of Chiropractors, Section 7, paragraph 4 is amended to read:

#### Section 7, paragraph 4

"A chiropractor shall ensure that his/her conduct in the practice of his/her profession is above reproach, and that he/she will take neither physical, emotional nor financial advantage of his/her patient".

#### Section 10 is amended to read:
