REPORTING REQUIREMENTS

**Order No. 02/11.** The AGRI-FOOD COUNCIL, pursuant to the provisions of *The Agri-Food Act, 2004*, hereby determines and orders as follows:

- 1 Council requires that all agencies established under the Act appoint a Board member to act as an Audit Chair for the purposes of ensuring timely and accurate financial reporting.
- 2 Council requires that the following five required reports be included in each agency's annual report:
  - (a) an audit report on the financial statements;
  - (b) an audit report on the rules and procedures to safeguard and control agency assets;
  - (c) an audit report on compliance with authorities;
  - (d) a statement comparing actual results to budgeted results in the audited financial statements; and
  - (e) a payee list with Board of Director approved thresholds disclosed.
- 3 Council requires all agencies to submit to the Agri-Food Council office eight hardcopies and one electronic copy of their annual report no later than one week after the date of their Annual General Meeting.
- 4 Council requires that the Reporting Standards Certification be signed and dated by each agency's Audit Chair and submitted to the Council with the agency's annual report.
- 5 Council requires that all agencies submit to the Agri-Food Council office a signed copy of their annual general meeting and board meeting minutes within two weeks of their approval.
- 6 Any agency that fails to comply with this Order could be found guilty of an offence and liable on summary conviction as per clause 42(1)(c), subsections 42(2) and (3) of the Act.
- 7 All fines will be recorded in the Council's annual report.

8 Agri-Food Council Order No. 01/09 is hereby wholly revoked.

9 This Order will remain in effect for a period no longer than ten years from the date this Order is approved by the Agri-Food Council.

CODE OF ETHICAL PRINCIPLES AND RULES OF CONDUCT AMENDMENTS

**The Code of Ethical Principles and Rules of Conduct are amended as follows:**

**(1) The first paragraph of the Rules of Conduct is repealed and replaced by the following:**

“The Rules of Conduct provide specific statements of the minimum standards of acceptable professional behaviour. They provide clearer statements about specific ethical issues, but do not exhaust the range of enforceable ethical standards. They are organized under the headings of the Ethical Principles to which they apply. The Rules of Conduct also provide guidance concerning the application of the Rules to certain specific situations. A member shall, when encountered with a circumstance or relationships not explicitly addressed in the Code of Ethical Principles and Rules of Conduct, comply with the ethical principles when evaluating the specific facts. The member shall be alert for such circumstances and relationships.”

**(2) R506 is repealed and replaced by the following:**

**“R506 Fees**

A member or firm engaged in the practice of public accounting shall establish a fee structure and shall ensure that a fee quoted and/or charged to a client for the performance of professional services is sufficient in that:

- (a) independence, where required, will not be impaired;
- (b) qualified members of the firm will be assigned to the engagement and will devote appropriate time to it; and,
- (c) the quality of work will not be impaired and that due care will be applied to comply with all applicable professional standards, guidelines, and quality control procedures in the performance of those services.

**R506.1 Absence of Fees**

Providing the conditions in R506 (a), (b) and (c) are met, a member or firm is permitted to provide pro bono professional services”.

**(3) The following Rules are added after Rule R520:**

**“R521 – General Business Principles**

Members in business may be solely or jointly responsible for the preparation and reporting of financial and other information, which both their employing organizations and third parties may rely on. They may also be responsible for providing effective financial management and competent advice on a variety of business-related matters. Members in business are often involved in the preparation and reporting of information that may either be made public or used by others inside or outside the employing organization.

Such information may include financial or management information; for example, forecasts and budgets, financial statements, management discussion and analysis, and the management letter of representation provided to the auditor's audit of the entity's financial statements. As such, a member shall:

- (a) recognize that investors, creditors, employers and other sectors of the business community, as well as governments and the public at large, all may rely on the work of a member in business;
- (b) prepare or present such information fairly, honestly and in accordance with relevant professional standards so that the information will be understood in its context;
- (c) recognize their responsibility to further the legitimate aims of their employing organization.

**“R522 – Responsibility to Encourage an Ethics-based Culture**

A member shall recognize that the more senior their position, the greater their ability and opportunity to influence events, practices and attitudes. A member shall encourage an ethics-based culture in their organization that emphasizes the importance of ethical behaviour.

**“R523 – Remedies Exhausted**

In circumstances where a member believes that unethical behaviour or actions by others will continue to occur within the organization, the member shall consider obtaining legal advice. In those extreme situations where all available remedies have been exhausted, a member in business must consider that the only appropriate action is to resign from the employing organization”.

**(4) The following definition is added under “Definitions”:**

**“Member in Business”** A member employed or engaged in an executive or non-executive capacity in such areas as commerce, industry, service, the public sector, education, the not for profit sector, regulatory bodies or professional bodies, or a member contracted by such entities.”
