ORDER for Increasing Weight Designation on Provincial Highway No. 49.

For the purpose of managing traffic on and protecting provincial highways, NOTICE IS HEREBY GIVEN that effective 12:01 a.m., December 9, 2011 unless restricted by a Minister's Order issued pursuant to *The Highways and Transportation Act, 1997*, this Order authorizes any person, vehicle or class of vehicles to operate at the weights set for primary highways by *The Vehicle Weight and Dimension Regulations, 2010*, on Provincial Highway No. 49 from the junction with Provincial Highway No. 38 near Kelvington west to the junction with Provincial Highway No. 35, with the exception of April, May, and June of each year.

This Order will remain in effect until February 18, 2021 unless sooner varied or rescinded.
