- 4 The Board has applied to the Minister to have the Board Order approved.
- 5 It is in the public interest to approve the Board Order.

Therefore, pursuant to subsection 12.1(4) of *The Assessment Management Agency Act*, I hereby approve the Order of the Saskatchewan Assessment Management Agency dated April 16, 2012, (a copy of which is attached) which approves the Amendments to Saskatchewan Assessment Manual – 2011 Base Year, considered by the Board on April 16, 2012, which will be used to determine regulated heavy industrial property assessments in Saskatchewan for the years 2013 to 2016.
