MINISTER'S ORDER/ARRÊTÉ MINISTÉRIEL

The Municipalities Act [sections 53, 56, 57, 59, 61, 62 and 63]

ALTERATION OF BOUNDARIES — BETWEEN THE RESORT VILLAGE OF NORTH GROVE AND THE RURAL MUNICIPALITY OF DUFFERIN NO. 190

1 Pursuant to sections 53, 56, 57, 59, and 61 of *The Municipalities Act*, the Council of the Resort Village of North Grove has submitted an application to alter its boundaries to the Minister of Municipal Affairs.

2 Upon consideration of the application, the Minister is of the opinion that the municipalities affected will be viable entities following the alteration of boundaries. Therefore, the undersigned hereby orders, pursuant to sections 61, 62, and 63 of *The Municipalities Act*, that:

(a) the boundaries of the Resort Village of North Grove and the Rural Municipality of Dufferin No. 190 be altered by withdrawing from the rural municipality and adding to the village the territory described in Schedule A;

(b) Schedule B is conclusively deemed to be the legal description of the boundary of the Resort Village of North Grove; and

(c) the alteration shall take effect on and from the date of this Order.

SCHEDULE A

The boundaries of the Resort Village of North Grove are altered by adding to the Village and withdrawing from the Rural Municipality of Dufferin No. 190 the territory lying within:

Section 9, Township 20, Range 26, West of the Second Meridian and described as:

(a) that portion lying within a line commencing at the point of intersection between the north-eastern boundary of Daniel Dr. shown on Plan No. 85MJ13075 and the western boundary of the road allowance defining the eastern limit of the south-east quarter of Section 9, Township 20, Range 26, West of the Second Meridian, then northerly along the western boundary of the said road allowance a distance of 87.828 m, then north-easterly at an angle of 115°07'21" a distance of 77.865 m to the point of intersection with the north-eastern boundary of Daniel Dr. shown on Plan No. 85MJ13075, then south-easterly along the north-eastern boundary of Daniel Dr. shown on Plan No. 85MJ13075 a distance of 147.904 m to the point of commencement.

Unless otherwise specified, the sections and portions of sections described in the above schedules include the adjoining south and west road allowances, intersections thereof and widenings thereto by plan of survey.

Order No. 07/12. The SASKATCHEWAN OAT DEVELOPMENT COMMISSION, pursuant to the provisions of *The Oat Development Plan Regulations* and *The Agri-Food Act, 2004*, hereby determines and orders as follows:

- 1 The Commission may act as an agent for registered producers in matters relating to the Scientific Research and Experimental Development (SR&ED) Program.
- 2 All SR&ED transactions by the Commission will constitute a transaction made by registered producers.
- 3 The appropriate percentage of levy contributions will be considered as a payment directly from registered producers to the researchers and developers under the SR&ED.
- 4 The Commission will:
 - (a) ensure registered producers have a preferential right to exploit the results of the SR&ED;
 - (b) determine the SR&ED projects that will be funded each year by holding a vote at meetings of the Saskatchewan Oat Development Commission Board of Directors;
 - (c) file an SR&ED claim each year on behalf of their members within six months of their fiscal year end to assist registered producers in receiving their tax credit entitlements on a timely basis;
 - (d) in cases where registered producers cannot determine the SR&ED contribution, provide that information when possible;
 - (e) provide each registered producer with information identifying the percentage of the total levy that was used to fund SR&ED in the year; and
 - (f) advise registered producers in which province the SR&ED was performed.

5 This Order will remain in effect for a period no longer than ten years from the date this Order is approved by the Agri-Food Council.
