### ALTERATION OF BOUNDARIES — BETWEEN THE CITY OF YORKTON AND THE RURAL MUNICIPALITY OF ORKNEY NO. 244

- 1 Pursuant to sections 43, 44, and 51 of *The Cities Act*, the Council of the City of Yorkton has submitted an application to alter its boundaries to the Saskatchewan Municipal Board, and the Saskatchewan Municipal Board has approved the application.
- 2 Therefore, the undersigned hereby orders, pursuant to subsection 44(3) of *The Cities Act* that:
  - (a) the boundaries of the City of Yorkton and the Rural Municipality of Orkney No. 244 be altered by withdrawing from the Rural Municipality and adding to the City the territory described in Schedule A;
  - (b) Schedule B is the description of the new boundaries of the City of Yorkton; and
  - (c) the alteration shall take effect on and from the date of this Order.

#### SCHEDULE A

The boundaries of the City of Yorkton, in the Province of Saskatchewan, are hereby altered by withdrawing from the Rural Municipality of Orkney No. 244 and adding to the City of Yorkton the following territory in the Province of Saskatchewan, described as:

Township 26, Range 4, West of the Second Meridian:

- (1) the following portion of Section 26:
  - (a) that portion of the south-east quarter consisting of:
    - (i) Parcel M, Plan No. 94Y07119 Ext 1;
- (2) Section 23;
- (3) the south half of Section 13;

- (4) the north half of Section 12;
- (5) the north-west quarter of Section 10;
- (6) the north half of Section 9;

Township 25, Range 4, West of the Second Meridian:

- (1) the north half of Section 26;
- (2) the following portion of the south-west quarter of Section 26:
  - (a) Surface Parcel No. 164238240.

#### SCHEDULE B

The boundaries of the City of Yorkton shall comprise the territory in the Province of Saskatchewan lying within:

Township 25, Range 4, West of the Second Meridian and described as:

- (1) the north-west quarter of Section 25, EXCLUDING that portion of the roadway shown on Plan No. 62Y05821 lying to the south of the westerly production of the southern boundary of Parcel A, shown on Plan No. 69Y07721, and that portion of the roadway shown on Plan No. 68Y07040;
- (2) the following portions of Section 26;
