ALTERATION OF BOUNDARIES — BETWEEN THE CITY OF WEYBURN AND THE RURAL MUNICIPALITY OF WEYBURN NO. 67

1 Pursuant to sections 43, 44, and 51 of *The Cities Act*, the Council of the City of Weyburn has submitted an application to annex land to the Minister of Government Relations in the form prescribed by the Minister together with:

- (a) a map showing the proposed alteration of boundaries which involves withdrawing territory from the Rural Municipality of Weyburn No. 67 and adding it to the City of Weyburn;
- (b) a certified copy of a resolution from the Council of the City of Weyburn requesting the proposed alteration of boundaries; and
- (c) a certified copy of a complementary resolution from the Council of the Rural Municipality of Weyburn No. 67.

2 As it is considered desirable to alter the boundaries of the City of Weyburn, the undersigned hereby orders, pursuant to sections 43, 44, and 51 of *The Cities Act* that:

- (a) the boundaries of the Rural Municipality of Weyburn No. 67 and the City of Weyburn be altered by withdrawing from the Rural Municipality and adding to the City the territory described in Schedule A;
- (b) Schedule B is conclusively deemed to be the legal description of the boundaries of the City of Weyburn; and
- (c) the alterations shall take effect on and from the date of this Order.

Pursuant to the authority vested in me by clause 54(1)(b) and section 118 of *The Education Act, 1995*, and in compliance with section 357 of the said Act, I, Russ Marchuk, Minister of Education, do hereby order the following, effective the date of this Order, in the manner set forth herein:

1 That the following lands be transferred from the Sun West School Division No. 207 of Saskatchewan to the Prairie Spirit School Division No. 206 of Saskatchewan:

In Township 30, Range 3: the north-west quarter of section 6;

All West of the Third Meridian.

Excepting those lands included within the boundaries of an Indian Reserve.

2 That the education portion of any property tax arrears on the aforementioned lands shall be payable to the Board of Education of the Sun West School Division No. 207 of Saskatchewan and further, that the education portion of property taxes owing or already paid for the current year on the said lands shall be apportioned between the two boards of education in a mutually accepted manner.

3 That all parcels of the aforementioned lands that may be registered in the name of the Board of Education of the Sun West School Division No. 207 of Saskatchewan, or their predecessors shall be vested in the name of the Board of Education of the Prairie Spirit School Division No. 206 of Saskatchewan.
