SASKATCHEWAN REGISTERED NURSES ASSOCIATION —  
REGULATORY BYLAW AMENDMENTS

**Pursuant to subsection 15(2) of *The Registered Nurses Act, 1988*, the regulatory bylaws of the Saskatchewan Registered Nurses' Association are amended as follows:**

**Bylaw IV Subsection 2(3) is amended to read:**

- “(3)(a) to adhere to the Canadian Nurses Association *Code of Ethics for Registered Nurses* contained in bylaw XIV; and
- (b) to adhere to the nursing standards and competencies for the practice of registered nursing contained in bylaw XV”.

**Bylaw IV Subsection 3(3) is amended to read:**

- “(3)(a) to adhere to the Canadian Nurses Association *Code of Ethics for Registered Nurses* contained in bylaw XIV; and
- (b) to adhere to the nursing standards and competencies for the practice of registered nursing contained in bylaw XV”.

**Bylaw V Clause 1(1)(a) is amended to read:**

- “(1) The registrar shall:
- (a) keep a register containing the following information for each nurse registered:
- (i) registration number;
  - (ii) name and address;
  - (iii) category of practice;
  - (iv) licence issued;
  - (v) any additional authorized practice in the general practice category;
  - (vi) specialty, if any, in the nurse practitioner category;
  - (vii) encumbrances, conditions or restrictions on the licence; and
  - (viii) such other information as may be required; and”

**Bylaw V Clause 3(2)(a) is amended to read:**

- “(2) A person who has not maintained eligibility for registration in accordance with section 3(1) must:
- (a) complete a re-entry program;”

**Bylaw V.1 Clause 1(4)(a) is amended to read:**

- “(4) As part of the continuing competence program, a registered nurse must complete, in each membership year, a reflective practice review in the form provided by the association, which includes:
- (a) a personal assessment of her or his own nursing practice according to the nursing practice standards;”

**Bylaw V.1 Subsection 1(8) is deleted.**

**Bylaw VI Section 2 is amended to read:**

- “(1) Membership in the general practice category is limited to:
- (a) a registered nurse who has practising membership status; and
  - (b) a graduate nurse who has graduate nurse membership status.
- (2) Additional authorized practice will be recognized for a registered nurse in good standing in the general practice category who has:
- (a) successfully completed additional nursing education courses approved or recognized by the association, or successfully completed a prior learning assessment;
  - (b) completed an application for authorized practice; and
  - (c) paid the requisite fees.
- (3) In the course of engaging in the practice of registered nursing in the general practice category, a registered nurse with additional authorized practice may, subject to conditions or restrictions imposed on his or her licence, perform the following:
- (a) in accordance with standards, competencies and clinical decision tools adopted by the association, diagnose and treat limited common medical disorders as defined in the clinical decision tools.
  - (b) in accordance with standards, competencies and clinical decision tools adopted by the association, order, perform, receive and/or interpret reports of screening and diagnostic tests;
  - (c) in accordance with standards, competencies and clinical decision tools adopted by the association, prescribe and/or dispense drugs in accordance with provincial and federal legislation:
    - (i) drugs listed in schedules I, II and III of *The Drug Schedules Regulations 1997*, as included in the bylaws of *The Saskatchewan College of Pharmacists*, as amended from time to time;
    - (ii) drugs in the Health Canada Non-Insured Health Benefits list, as amended from time to time; and
    - (iii) drugs and Natural Health Products that may be sold without a prescription.
  - (d) in accordance with standards, competencies and clinical decision tools adopted by the association, perform minor surgical and invasive procedures.
- (4) A registered nurse with additional authorized practice shall adhere to standards, competencies and clinical decision tools listed in the association publication dated May 2013 entitled *Standards, Competencies and Clinical Decision Tools for the Registered Nurse with Additional Authorized Practice*.

**MAINTAINING ELIGIBILITY**

- (5) To maintain eligibility for additional authorized practice, a general category registered nurse must:
- (a) work in the additional authorized practice activities for at least 900 hours in the three years immediately preceding the registration year for which registration is sought;
  - (b) maintain current certification in required external courses approved or recognized by the association; and
  - (c) include the member’s additional authorized practice activities in the reflective practice review as part of the annual continuing competence program.
- (6) A registered nurse who does not complete a reflective practice review related to additional authorized practice activities in a membership year is not eligible for enrolment on the additional authorized practice register in the following membership year.

(7) The registrar may suspend a registered nurse's enrolment on the additional authorized practice register when the registrar determines that the registered nurse has not completed a reflective practice review related to additional authorized practice activities.

(8) A registered nurse who is on the additional authorized practice register, who practices less than 900 hours in the preceding three years, must satisfactorily complete additional education courses or learning activities to address the standards, competencies and clinical decision tools in the additional authorized practice”.

**Bylaw VI Clauses 3(3)(a) to (d) and Subsection (5) are amended by striking out the phrase “established by council”.**

**Bylaw VI Subsection 3(4) is amended by striking out the phrase “it establishes”.**

**Bylaw VI Subclause 3(6)(c)(i) and Clause (d) are amended by striking out the phrase “approved or recognized by council”.**

**Bylaw VI Subsection 3(8) is amended to read:**

“(8) To maintain eligibility for registration in the nurse practitioner category, a registered nurse must:

- (a) work in nursing practitioner activities approved by the association for at least nine hundred hours in the three years immediately preceding the application; and
- (b) hold a membership in the nurse practitioner category with the association or a regulatory body recognized by the association while working in approved nurse practitioner activities for these hours to contribute to eligibility for registration”.

**Bylaw VI Subsection 3(9) is amended as follows:**

(9) A registered nurse with a licence in the nurse practitioner category who practices less than 900 hours in the nurse practitioner category in the preceding three years must:

**Existing (a) is repealed and replaced with:**

“(a) satisfactorily complete additional nurse practitioner education courses or learning activities to address the competencies and standards required of a nurse practitioner”.

**Existing (b) is deleted.**

**Existing (c) becomes new (b).**

**Bylaw VI is amended by adding new Section 4:**

#### “SECTION 4. THE PRESCRIPTION REVIEW PROGRAM

- (1) The association shall participate in the Prescription Review Program established in Saskatchewan.
- (2) Panel of Monitored Drugs – The Prescription Review Program shall apply to all dosage forms of the following drugs, except where indicated otherwise:

ACETAMINOPHEN WITH CODEINE: in all dosage forms except those containing 8 mg or less of codeine

ACETYLSALICYLIC ACID (ASA) WITH CODEINE: in all dosage forms except those containing 8 mg or less of codeine

AMPHETAMINES: in all dosage forms

ANABOLIC STEROIDS:

ANILERIDINE: in all dosage forms

BARBITUATES:

BENZODIAZEPINES: in all dosages and forms

BUPRENORPHINE: in all dosages and forms

BUTALBITAL: in all dosage forms

BUTALBITAL WITH CODEINE: in all dosage forms

BUTORPHANOL

CHLORAL HYDRATE:

COCAINE: in all dosage forms

CODEINE: as the single active ingredient, or in combination with other active ingredients, in all dosage forms except those containing 20 mg per 30 ml or less of codeine in liquid for oral administration

DIETHYLPROPION: in all dosage forms

FENTANYL: in all dosage forms

GABAPENTIN:

HYDROCODONE – DIHYDROCODEINONE: in all dosage forms

HYDROMORPHONE – DIPHYDROMORPHONE: in all dosage forms

LEVORPHANOL: in all dosage forms

MEPERIDINE – PETHIDINE - in all dosage forms

METHADONE: in all dosage forms

METHYLPHENIDATE: in all dosage forms

MORPHINE: in all dosage forms

NORMETHANDONE-P-HYDROXYEPHEDRINE - in all dosage forms

OXYCODONE: as the single active ingredient or in combination with other active ingredients in all dosage forms

OXYMORPHONE:

PANTOPON: in all dosage forms

PENTAZOCINE: in all dosage forms

PHENTERMINE: in all dosage forms

PROPOXYPHENE: in all dosage forms

(3) Prescriptions for drugs covered by the Prescription Review Program shall be issued by a RN(NP) according to the policies and procedures agreed to by the College of Dental Surgeons of Saskatchewan, the College of Physicians and Surgeons of Saskatchewan, the Saskatchewan Registered Nurses' Association and the Saskatchewan College of Pharmacists.

(4) In order to prescribe a drug to which the Prescription Review Program applies, a RN(NP) shall complete a written prescription which meets federal and provincial legal requirements and includes the following:

- (a) the patient's date of birth;
- (b) the patient's address;
- (c) the total quantity of medication prescribed, both numerically and in written form;
- (d) the patient's health services number; and,
- (e) the prescriber's name and address.

(5) For the purpose of this bylaw, “written prescription” includes an electronic prescription that meets the requirements for electronic prescribing under the Pharmaceutical Information Program.

(6) A RN(NP) who prescribes a drug to which the Prescription Review Program applies, and who provides the prescription directly to a pharmacy by electronic prescribing, by email or by FAX, or who transmits a prescription in accordance with the policies and protocols of the Pharmaceutical Information Program, need not include both the quantity numerically and in written form.

(7) RN(NP)s shall only prescribe part-fills of medications to which the Prescription Review Program applies if the following information is specified in the prescription:

- (a) the total quantity;
- (b) the amount to be dispensed each time; and
- (c) the time interval between fills.

(8) The office of the Registrar may gather and analyze information pertaining to the prescribing of medications to which the Prescription Review Program applies in Saskatchewan for the purpose of limiting the inappropriate prescribing and inappropriate use of such drugs. In order to fulfill that role, the office of the Registrar may, among other activities:

- (a) generally, provide education to RN (NP)s in order to encourage appropriate prescribing practices by RN(NP)s;
- (b) alert RN(NP)s to possible inappropriate use of medications to which the Prescription Review Program applies by patients to whom they have prescribed such drugs;
- (c) alert RN(NP)s to possible inappropriate prescribing of medications to which the Prescription Review Program applies;
- (d) make recommendations to a RN (NP) with respect to that member’s prescribing of medications to which the Prescription Review Program applies;
- (e) require a RN(NP) to provide explanations of his or her prescribing of medications to which the Prescription Review Program applies. In making requests for an explanation, the office of the Registrar may require the member to provide information about the patient, the reasons for prescribing to the patient, and any knowledge which the member may have about other narcotics or controlled drugs received by the patient;
- (f) cause information, concerns or opinions of general application to the profession to be communicated to the RN(NP)s without identifying the particular member to whom such information relates;
- (g) provide information gathered in connection with the Prescription Review Program to another health professional regulatory body including the College of Dental Surgeons of Saskatchewan, the Saskatchewan College of Pharmacists or the College of Physicians and Surgeons of Saskatchewan, provided the information gathered is required by that body to perform and carry out the duties of that health professional regulatory body pursuant to an Act with respect to regulating the profession. Where the personal health information relates to a member of the health professional body seeking disclosure, disclosure by the office of the Registrar of that information may only be made in accordance with *The Health Information Protection Act*, and in particular section 27(5) of that Act.

(9) A RN(NP) shall respond to such requests for explanation, as described in paragraph (8)(e) above, from the office of the Registrar within 14 days of receipt of such a request for information.

(10) The office of the Registrar may extend the deadline for reply at his or her discretion, upon receipt of a written request for extension from the member.

(11) A RN(NP) who receives such a request for information shall comply, to the best of his or her ability, fully and accurately with such requests for information.



(12) The association may enter into an agreement with a person or organization to do any or all of the following:

- (a) access and analyze information in the prescription review database pertaining to RN(NP) prescribing;
- (b) advise the SRNA of concerns pertaining to RN(NP) prescribing;
- (c) advise the SRNA of possible inappropriate use of medications to which the Prescription Review Program applies by patients to whom RN(NP)s have prescribed such medications;
- (d) provide general education to RN(NP)s pertaining to prescribing of Prescription Review Program medications; and
- (e) alert the SRNA to possible inappropriate use of medications to which the Prescription Review Program applies by patients to whom a RN(NP) has prescribed such medications.

(13) Failure to comply with paragraphs (8)(e), (9) and (11) above is professional misconduct pursuant to section 26(2)(m) of *The Registered Nurses Act, 1988*”.

**Bylaw XV, Standards, Competencies and Nursing Education Program Approval is amended to read:**

“(1) The association adopts the standards and competencies contained in its March 1, 2007 publication entitled *Standards and Foundation Competencies for the Practice of Registered Nurses*. The association adopts the standards and competencies contained in its May 1, 2013 publication entitled *Standards and Foundation Competencies for the Practice of Registered Nurses* which will supersede the March 1, 2007 publication and take effect December 1, 2013.

(2) The association adopts the standards and competencies contained in its January 1, 2011 publication entitled *Registered Nurse (Nurse Practitioner) RN(NP) Standards and Core Competencies*.

(3) The association adopts the standards and competencies contained in its October 2003 publication entitled *Clinical Expectations for RN(NP)s*.

(4) The association adopts its September 2009 publication entitled *Nursing Education Program Approval Process – Administrative Document for Approval of Nursing Education Programs for Registered Nurses and Approval of Nursing Education Re-entry Programs for Registered Nurses*.

(5) The association adopts its February 2011 publication entitled *Nursing Education Program Approval Process – Administrative Document for Approval of Nursing Education Programs for Registered Nurse (Nurse Practitioner)s*.

(6) The association adopts its May, 2013 publication entitled *Nursing Education Program Approval Standards and Criteria for the Registered Nurse with Additional Authorized Practice Courses*”.
