AMENDING ORDER –**HOLY TRINITY ROMAN CATHOLIC SEPARATE SCHOOL DIVISION NO. 22**

M.O. ED01/2016-17. Pursuant to the authority vested in me by section 40, clause 42(1)(e), section 54, section 61 of *The Education Act, 1995*, I, Don Morgan, Minister of Education, do hereby order the following with respect to the Holy Trinity Roman Catholic Separate School Division No. 22 of Saskatchewan, in the manner set forth herein:

- 1 That the number of members comprising the Board of Education be reduced from eight (8) to seven (7):
 - (a) four (4) members elected-at-large from the City of Moose Jaw, by electors resident within the area as follows:
 - (i) Township 17, Range 26, those portions of Sections 2 to 10, 17, and 18 lying within the incorporated boundary of the City of Moose Jaw;
 - (ii) Township 17, Range 27, those portions of Sections 1, 12 and 13 lying within the incorporated boundary of the City of Moose Jaw;
 - (iii) Township 16, Range 26, those portions of Sections 19 to 21, 27 to 35 lying within the incorporated boundary of the City of Moose Jaw;
 - (iv) Township 16, Range 27, those portions of Section 25 to 27, 34 to 36 lying within the incorporated boundary of the City of Moose Jaw;

All West of the Second Meridian.

Excepting those lands included within the boundaries of an Indian Reserve.

- 2 That the subdivisions be renumbered and altered for the following areas:
 - (a) two (2) members elected-at-large from the City of Swift Current, by the electors resident within the area as follows:
 - (i) Township 15, Range 13, Sections 17 to 20, the south half of Section 29, and that portion of the south half of Section 30 lying south of Chaplin St.;
 - (ii) Township 15, Range 14, Sections 13 to 15 and 22 to 24, that portion of the south half of Section 25 lying south of Chaplin St., and that portion of the south half of Section 26 lying south of Chaplin St., east of Kirkaldie Ave., and south of North Railway St., and that portion of the south half of Section 27 lying south of North Railway St.;
 - (ii) Township 15, Range 13, Sections 31 and 32, the north halves of Sections 29 and 30, and that portion of the south half of Section 30 lying north of Chaplin St.;
 - (iii) Township 15, Range 14, Sections 34 to 36, the north halves of Sections 25 to 27, that portion of the south half of Section 25 lying north of Chaplin St., and that portion of the south half of Section 26 lying north of Chaplin St., west of Kirkaldie Ave., and north of North Railway St., and that portion of the south half of Section 27 lying north of Railway St.;
 - (iv) Township 16, Range 13, Sections 5 and 6; and
 - (v) Township 16, Range 14, Sections 1 to 3.

All West of the Third Meridian.

Excepting those lands included within the boundaries of an Indian Reserve.

(b) one (1) member from the Town of Shaunavon, elected by residents within the geographic area as follows:

Subdivision No. 1 – Shaunavon

(i) Township 8, Range 18, Sections 7 to 10, 15 to 18, the south halves of Sections 19 to 22; and

(ii) Township 8, Range 19, Sections 11 to 14 and the south halves of Sections 23 and 24.

All West of the Third Meridian.

3 In accordance with section 10 of *The Local Government Election Act, 2015*, the revised subdivision and trustee structure shall be effective for the next upcoming general election on October 26, 2016.

ALTERATION OF BOUNDARIES – BETWEEN THE RESORT VILLAGE OF SHIELDS AND
THE RURAL MUNICIPALITY OF DUNDURN NO. 314

1 Pursuant to sections 53, 56, 57, 59, and 61 of *The Municipalities Act*, the Council of the Resort Village of Shields has submitted an application to alter its boundaries to the Minister of Government Relations.

2 Upon consideration of the application, the Minister is of the opinion that the municipalities affected will be viable entities following the alteration of boundaries. Therefore, the undersigned hereby orders, pursuant to sections 61, 62, and 63 of *The Municipalities Act*, that:

(a) the boundaries of the Resort Village of Shields and the Rural Municipality of Dundurn No. 314 be altered by withdrawing from the rural municipality and adding to the Resort Village the territory described in Schedule A;

(b) schedule B is conclusively deemed to be the legal description of the boundary of the Resort Village of Shields; and

(c) the alteration shall take effect on and from the date of this Order.

The boundaries of the Resort Village of Shields are altered by adding to the resort village and withdrawing from the Rural Municipality of Dundurn No. 314 territory lying within:

Township 33, Range 3, West of the Third Meridian and described as:

(1) The following portions of the south-east quarter of Section 7:

(a) Road Plan No. 69S02467, lying north of a line being the westerly production of the south limit of Plan No. 102035090.

The boundaries of the Resort Village of Shields shall comprise the territory in the Province of Saskatchewan lying within:

Township 33, Range 3, West of the Third Meridian and described as:

- (1) the following portions of Section 7:
 - (a) all that portion of the east half as shown on Registered Plan Nos. 69S19949, 102000542 and 102035090;

- Division 4: North half Township 29, Range 13; and Township 30, Range 13;
- Division 5: North half Township 29, Range 14; and Township 30, Range 14;
- Division 6: North half Township 29, Range 15; and Township 30, Range 15.

IT IS FURTHER ORDERED THAT:

1 The effective date of the boundary alteration for Division 5 and elimination of Division 7 is October 26, 2016.

2 An election for a councillor to represent Division 5, as described herein, will be held at the next general election held on October 26, 2016, to coincide with the effective date of the boundary alterations.
