Whereas subsection 15(1) of *The Operation of Public Registry Statutes Act* reads as follows:

“15(1) Notwithstanding any other Act or law, if, in the opinion of a registry officer or the minister, the circumstances are such that it is not practical to provide one or more registry services or functions, a registry officer or the minister may, by order, suspend all or any registry services or functions for the period during which, in the opinion of the registry officer or the minister, those circumstances prevail”.

Therefore I, Karen E. Banks, Registrar of Titles, do hereby determine that ISC must take the following actions during the recommencement of Land Registry services and functions:

(a) Protecting Priority in the Queue – packets made available to registry personnel for the purpose of evaluating and testing the system from 8:45 a.m. to 9:20 a.m. on Friday, December 9, 2016.

On Friday, December 9, 2016, the Land Registry services and functions were partly restored to permit testing of the Land Registry services and functions, and a small number of packets were made available for examination and registration.

Prior to full recommencement of Land Registry services and functions, ISC must take the steps necessary to confirm whether judgments should attach as a result of these registrations and any affected titles must be immediately locked prior to Registry services and functions being made available to the public. In the event that judgments should attach, Registrar's corrections shall be performed to protect the rights of judgment creditors.

(d) Protection of the Rights of Interest Holders – where lapse procedure commenced under section 63 of *The Land Titles Act, 2000*.

With the service disruption, an interest holder may have lost opportunity to defend against a lapse process that has been commenced under section 63 due to the requirement that the interest holder take action within a 30 day time period in accordance with subsection 46(7) of *The Land Titles Regulations, 2001*.
