**CHAPTER F-13.4 REG 4**

*The Financial Administration Act, 1993*

Section 71

Order in Council 757/93, dated October 6, 1993

(Filed October 7, 1993)

**Title**

1 These regulations may be cited as *The Saskatchewan Liquor Board Employees' Income Tax Remission Regulations*.

**Interpretation**

2 In these regulations:

(a) “**Act**” means *The Income Tax Act*;

(b) “**strike pay**” means strike pay that was received in respect of the strike against the Saskatchewan Liquor Board that began on November 26, 1979 and that ended on December 17, 1979; and

(c) “**taxpayer**” means a taxpayer:

(i) who was a member of the Liquor Board Branch of the Saskatchewan Government Employees' Union in 1979;

(ii) whose income, for the purposes of an assessment pursuant to the Act, included an amount of strike pay that was received in 1979; and

(iii) who did not object to the assessment referred to in subclause (ii).

**Remission granted**

3 Remission is granted to a taxpayer of taxes, interest and penalties payable pursuant to the Act by the taxpayer that would not have been payable if strike pay had not been included in the computation of the taxpayer's income for the purposes of an assessment pursuant to the Act.

**Coming into force**

4 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**CHAPTER H-0.01 REG 1**

*The Health Districts Act*

Section 40

Order in Council 755/93, dated October 6, 1993

(Filed October 7, 1993)

**Title**

1 These regulations may be cited as *The Health Districts Amalgamation Regulations*.

**Interpretation**

2 In these regulations:

(a) “**Act**” means *The Health Districts Act*;

(b) “**special resolution**” means a special resolution as defined:

(i) in *The Co-operatives Act, 1989*, in the case of a health corporation incorporated or continued pursuant to that Act;

(ii) in *The Non-profit Corporations Act*, in the case of a health corporation incorporated or continued pursuant to that Act.

**Health corporations prescribed**

3 The bodies corporate set out in Part I of the Appendix are prescribed as health corporations for the purposes of clause 2(h) of the Act.

**Form 1 prescribed**

4 Form 1 of Part II of the Appendix is prescribed as the notice of amalgamation for the purposes of section 14 of the Act.

**Approval of amalgamations**

5(1) For the purposes of subsection 14(4) of the Act, an amalgamation with respect to a health corporation that is incorporated or continued pursuant to *The Non-profit Corporations Act* or *The Co-operatives Act, 1989* may be approved by the members of the health corporation by a special resolution of the members.

(2) A special resolution to approve an amalgamation must specify the date on or before which the amalgamation is to become effective.

(3) Notwithstanding anything in *The Non-profit Corporations Act* or *The Co-operatives Act, 1989*, each member of a health corporation is entitled to vote on the special resolution, whether or not the member's membership otherwise carries the right to vote, and the members shall vote as one class.

**Coming into force**

6 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

## SASKATCHEWAN REGULATIONS 80/93

### *The Saskatchewan Medical Care Insurance Act*

#### Section 48

Order in Council 754/93, October 6, 1993

(Filed October 7, 1993)

#### Title

**1** These regulations may be cited as *The Medical Care Insurance Beneficiary and Administration Amendment Regulations, 1993 (No. 2)*.

#### R.R.S. c.S-29 Reg 13 amended

**2** *The Medical Care Insurance Beneficiary and Administration Regulations* are amended in the manner set forth in these regulations.

#### Subsection 14(1) amended

**3** **Subsection 14(1) is amended by striking out the portion preceding clause (a) and substituting the following:**

“(1) For the purposes of clause 15(a.1) of the Act and subject to the other provisions of section 15 of the Act, a laboratory procedure is an insured service where it is included in List 1 or List 2 of section V of the physician payment schedule, where it is provided entirely outside a hospital and where it is provided by:”.

#### New section 14.2

**4** **The following section is added after section 14.1:**

#### Laboratory services

“**14.2** For the purposes of subsection 14(3.1) of the Act and subject to section 15 of the Act, a laboratory service that is provided both outside a hospital and outside Saskatchewan and that is provided to a beneficiary by a specialist in pathology or by a person employed by a specialist in pathology for whose work the specialist assumes overall responsibility and to whom the specialist provides intermittent daily personal supervision, is an insured service, if the service:

- (a) has not been requisitioned by a physician practising in Saskatchewan;
- (b) is not available in Saskatchewan and has been requisitioned by a physician practising in Saskatchewan; or
- (c) is available in Saskatchewan and has been requisitioned by a physician practising in the City of Lloydminster”.

#### Coming into force

**5(1)** Subject to subsection (2), these regulations come into force on the day on which *The Saskatchewan Medical Care Insurance Amendment Act, 1993* is proclaimed in force.

(2) If *The Saskatchewan Medical Care Insurance Amendment Act, 1993* is proclaimed in force before these regulations are filed with the Registrar of Regulations, these regulations come into force on the day on which they are filed with the Registrar of Regulations.

**Title**

**1** These regulations may be cited as *The Uniform Building and Accessibility Standards Amendment Regulations, 1993*.

**R.R.S. c.U-1.2 Reg 5 amended**

**2** *The Uniform Building and Accessibility Standards Regulations* are amended in the manner set forth in these regulations.

**Section 3 amended**

**3 Subsection 3(1) is amended:**

(a) by striking out “and” after clause (b); and

(b) by adding the following clauses after clause (c):

“(d) the Third Revisions and Errata to the National Building Code of Canada 1990; and

“(e) the Fourth Revisions and Errata to the National Building Code of Canada 1990”.

**Section 16 amended**

**4 Section 16 is amended:**

(a) by striking out “subsections (2) and (3)” and substituting “subsection (2)” in subsection (1); and

(b) by striking out “described in this section” and substituting “required by these regulations to be barrier-free” in subsection (3).

**Section 4 amended**

**3** **Subsection 4(2) is amended by striking out** “and on or before September 30, 1993” **wherever it occurs.**

**4** **Subsection 6(1) is repealed and the following substituted:**

“(1) In order to be eligible for a grant, at least four units of eligible animals must be marketed:

(a) during the period commencing on November 1, 1992 and concluding on December 31, 1993;  
or

(b) after December 31, 1993, during a calendar year”.

**1** These regulations may be cited as *The Driver and Vehicle Registration Fee Amendment Regulations, 1993 (No. 3)*.

**R.R.S. c.H-3.1 Reg 1 amended**

**2** *The Driver and Vehicle Registration Fee Regulations, 1987* are amended in the manner set forth in these regulations.

**Section 2 amended**

**3** **The following clause is added after clause 2(e):**

“(e.1) ‘IRP’ means the International Registration Plan, being an agreement between jurisdictions in North America respecting commercial motor vehicle registration”.

**Section 3 amended**

**4** **Section 3 is amended:**

**(a)** by striking out “or” after clause (b);

**(b)** by adding the following clause after clause (b):

“(b.1) the applicant applies and is entitled to be registered pursuant to the IRP, the registration fee is the fee determined pursuant to the IRP; or”; **and**

**(c)** by striking out “or (b)” and substituting “, (b) or (b.1)” wherever it appears in clause (c).

**Section 5 amended**

**5** **Section 5 is amended:**

**(a)** by striking out “or” after clause (a);

**(b)** by adding the following clause after clause (a):

“(a.1) the registration fee, in the case an applicant who applies and is entitled to register the vehicle pursuant to the IRP, is the fee determined pursuant to the IRP; or”; **and**

**(c)** by striking out “clause (a)” and substituting “clause (a) or (a.1)” in clause (b).

**Section 9 amended**

**6** **Section 9 is amended:**

**(a)** by adding the following clause after clause (b):

“(b.1) the applicant applies and is entitled to register pursuant to the IRP, the registration fee is the fee determined pursuant to the IRP”; **and**

**(b)** by striking out “or (b)” and substituting “, (b) or (b.1)” in clause (c).

**Section 10 amended**

**7** **Section 10 is amended:**

**(a)** by striking out “or” after clause (b);

**(b)** by adding the following clause after clause (b):

“(b.1) the applicant applies and is entitled to register pursuant to the IRP, the registration fee is the fee determined pursuant to the IRP; or”; **and**

(c) by striking out “or (b)” and substituting “, (b) or (b.1)” wherever it appears in clause (c).

Section 27 amended

**8 Section 27 is amended:**

(a) by renumbering it as subsection 27(1);

(b) by adding “Subject to subsection (2),” before “where” in subsection (1);

(c) by adding the following subsection after subsection (1):

“(2) Where the fee to be paid for a certificate of registration may be prorated, and where the amount is calculated in another jurisdiction on behalf of Saskatchewan pursuant to the IRP, the registration fee calculated pursuant to these regulations:

(a) is to be prorated in accordance with subsection (1); or

(b) is to bear the same proportion to the total fee as the number of months for which the certificate is to be in force bears to 12 months, rounded to the nearest dollar”.

Coming into force

**9(1)** Subject to subsection (2), these regulations come into force on October 1, 1993.

(2) If these regulations are filed after October 1, 1993, these regulations come into force on the day on which they are filed with the Registrar of Regulations.

**1** These regulations may be cited as *The Registration Exemption and Reciprocity Amendment Regulations, 1993*.

R.R.S. c.H-3.1 Reg 4 amended

**2** *The Registration Exemption and Reciprocity Regulations, 1987* are amended in the manner set forth in these regulations.

Section 4.1 repealed

**3 Section 4.1 is repealed.**

New section 11.1

**4 The following section is added after section 11:**

Trailer, semi-trailer exemption

“**11.1** Where a person is ordinarily resident in another province and is the owner of a trailer or semi-trailer that has been registered in that province, the owner of that trailer or semi-trailer is exempt from the provisions of subsection 23(1) of the Act”.

Coming into force

**5(1)** Subject to subsections (2) and (3), these regulations come into force on October 1, 1993.

(2) If these regulations are filed after October 1, 1993, sections 1, 2, 4 and 5 of these regulations come into force on the day on which they are filed with the Registrar of Regulations.

(3) Section 3 of these regulations comes into force on December 31, 1993.
