Order in Council 255/96, dated April 16, 1996

(Filed April 17, 1996)

SHORT TITLE AND INTERPRETATION

Title

1 These regulations may be cited as *The Saskatchewan Flax Development Plan Regulations*.

Interpretation

- **2** In these regulations:
 - (a) **"Act"** means *The Agri-Food Act*;

(b) **"buyer"** means any person who buys or contracts to buy flax produced in Saskatchewan;

(c) **"commission**" means the Saskatchewan Flax Development Commission established pursuant to section 6 and includes the interim commission;

(d) "director" means a member of the commission;

(e) **"flax"** means the seeds, straw, fibre, shives, or any part of the plant *linum usitatissimum*;

(f) **"interim commission**" means the interim commission established pursuant to section 6;

(g) **"plan"** means the Saskatchewan Flax Development Plan established pursuant to section 3;

(h) **"processing"** means changing the nature, size, quality or condition of flax;

(i) **"processor"** means any person engaged in the business of processing flax;

(j) **"producer"** means:

(i) any person operating a farm in Saskatchewan who is engaged in the production and marketing of flax and includes the employer of that person;

(ii) a person who is entitled under any lease or agreement:

(A) to a share of the flax produced by a person mentioned in subclause (i); or

(B) to the proceeds from the sale of that flax; and

(iii) a person who takes possession of any flax under any form of security or legal proceedings for a debt;

(k) **"registered producer"** means a producer who is registered with the commission and whose registration is in good standing.

PLAN

Establishment

- **3**(1) The Saskatchewan Flax Development Plan is established.
- (2) The plan continues until these regulations are repealed.

Application

4 Subject to any exemptions made by the commission, the plan and the orders of the commission made pursuant to the plan apply to:

(a) all of Saskatchewan, all flax and all grades, classes or varieties of flax; and

(b) all persons engaged in the production or marketing of flax in Saskatchewan.

Purposes

5(1) The general purpose and intent of the plan is to provide for the orderly and effective development of the flax industry in Saskatchewan.

(2) Without limiting the generality of subsection (1), the specific purposes of the plan are:

- (a) to promote and develop the flax industry in Saskatchewan;
- (b) to develop procedures to maximize returns to producers of flax;
- (c) to encourage the production of a uniform high-quality product;

(d) to gather, compile and distribute information related to the production, consumption and marketing of flax;

(e) to conduct or encourage research on the production, marketing, processing and consumption of flax;

(f) to promote and improve understanding among individuals and organizations within the flax industry; and

(g) to establish a system of levies on flax for the purpose of carrying out the objectives of the plan.

COMMISSION

Administration of plan

6(1) The Saskatchewan Flax Development Commission is established as a development commission pursuant to section 5 of the Act.

(2) The commission shall administer the plan.

(3) Subject to subsection (4), the commission consists of a board of directors consisting of six registered producers elected in accordance with sections 18 to 20.

(4) An interim commission consisting of the persons listed in the Appendix shall administer the plan until a board of directors is elected in accordance with sections 18 to 20.

(5) The members of the interim commission are to be remunerated at the rate set out in the Appendix.

Powers of commission

7 The commission is vested with the power:

(a) to carry out educational, research and developmental programs related to the production and marketing of flax;

(b) to require any or all persons engaged in the production or marketing of flax to register with the commission;

(c) to require any person engaged in the production or marketing of flax to furnish any information or records relating to the production or marketing that the commission considers necessary;

(d) to set and collect registration fees and charges for services rendered by the commission from any person engaged in the production or marketing of flax;

(e) subject to section 15, to set and collect check-offs from any person engaged in the production or marketing of flax;

(f) to categorize into groups persons engaged in the production or marketing of flax for the purpose of setting and collecting:

- (i) the registration fees and charges mentioned in clause (d); and
- (ii) the check-offs mentioned in clause (e);
- (g) to recover:
 - (i) the registration fees and charges mentioned in clause (d); or
 - (ii) the check-offs mentioned in clause (e);

by suit in a court of competent jurisdiction;

(h) to employ any officers and other employees that it considers necessary to administer the plan and to determine their respective:

- (i) duties;
- (ii) conditions of employment; and
- (iii) remuneration;
- (i) to establish or support:
 - (i) a group insurance plan; and
 - (ii) any other pension or employee benefit program;

for the benefit of the officers and employees mentioned in clause (h) and their dependants;

- (j) to use any moneys received by the commission:
 - (i) to carry out the purposes of the plan; and
 - (ii) to pay the expenses of the commission;

(k) to borrow, raise or secure the payment of moneys in any manner that the commission thinks appropriate for the purpose of administering the plan;

- (l) to draw, make, accept, endorse, execute, issue, hypothecate or assign:
 - (i) promissory notes;
 - (ii) bills of exchange; or
 - (iii) other negotiable or transferable instruments;

(m) to purchase, take on lease or in exchange, or otherwise acquire real and personal property related to the business of the commission;

(n) to sell or otherwise dispose of any real or personal property acquired by the commission;

- (o) to grant:
 - (i) a mortgage against real property; or
 - (ii) a security interest in personal property;

acquired by the commission;

(p) to make any orders that are considered by the commission as necessary or advisable to carry out the purposes of the plan;

(q) to amend or revoke any of the orders mentioned in clause (p);

(r) to exempt from the plan and any order any category of persons engaged in the marketing of flax or any class, variety or grade of flax;

(s) to market, grade or insure flax, either as principal or agent;

(t) to enter into any agreement with any person, agency, organization, institution or body within or outside Saskatchewan for any purpose related to:

- (i) the exercise of any of the powers; or
- (ii) the carrying out of any of the duties;

of the commission in relation to the plan;

(u) to require any person who owes moneys to a producer with respect to the sale of any flax by the producer to that person to pay the moneys to the commission which shall then distribute the moneys, in a manner and fashion to be determined by the commission, to the producer to whom the moneys are owing;

(v) to purchase or acquire by any other means, in the open market or otherwise, shares, bonds, debentures or other securities of any incorporated company; and

(w) to hold, sell, transfer, or otherwise deal with any of the shares, bonds, debentures or other securities mentioned in clause (v) and to exercise any rights as owner of those shares, bonds, debentures or other securities, including the right to vote.

Books and records

8(1) The commission shall maintain any books and records that may be required for the proper administration of the plan and keep those books and records open for inspection by the council at any reasonable time.

- (2) The commission shall maintain its head office in Saskatchewan.
- (3) The commission shall prepare an annual report containing:

(a) a copy of the audited financial statement of the commission for its previous fiscal year;

(b) a description of the activities of the commission for its previous fiscal year; and

(c) a list of the names and addresses of the directors of the commission.

(4) The commission shall submit the annual report to the council and make it available at the annual general meeting of registered producers and, on request, to any registered producer or buyer.

(5) The registered producers shall appoint an auditor for the commission at the annual or at any special meeting of the registered producers, and the auditor shall audit the books and records of the commission.

Committees

9 The commission may appoint any committees that it considers necessary or desirable for the proper operation of the plan.

Operation of the commission

10(1) The commission shall elect a chairperson and vice-chairperson from among its members.

(2) The commission may appoint or hire a manager and any other staff or agents necessary to carry out the objectives of the plan.

(3) A majority of the commission constitutes a quorum at any meeting of the commission.

(4) The chairperson or, in the absence of the chairperson, the vice-chairperson shall preside at all meetings of the commission.

Orders of commission generally

11(1) Every order issued by the commission must:

(a) be signed by the chairperson or, in the absence of the chairperson, the vice-chairperson;

(b) clearly describe the program or policy established by the order; and

(c) be published in the Gazette and any other media determined by the commission.

(2) Every order issued by the commission and approved by the council pursuant to section 20 of the Act must be kept open for inspection by any producer, marketer of flax or person designated by the council.

(3) The commission shall annually review all orders issued by it.

Financial provisions

12(1) The commission may open accounts in a bank, credit union or trust corporation in the name of the commission and appoint signing officers.

(2) The commission may invest any money in its possession or control that is not immediately required for the purposes of its operations in securities approved for the investment of the general revenue fund pursuant to *The Financial Administration Act, 1993* and may sell any securities so acquired by it and reinvest any of the proceeds of those securities in a similar manner.

(3) The fiscal year of the commission is the crop year from August 1 to July 31.

(4) When the plan has been disestablished, any assets of the commission remaining after all of the liabilities of the commission have been settled are to be distributed to one or more research or development institutes that, in the opinion of the commission, will use those assets to contribute to the development of the flax industry in Saskatchewan.

REGISTRATION

Registration of producers

13(1) Producers shall register with the commission at the time and in the manner required by the commission.

(2) The commission may register as producers persons who have met the definition of "producer" at any time within the two years prior to registration.

(3) The commission shall maintain at its head office a register containing the name and address of each registered producer.

Registration of buyers and processors

14(1) Buyers and processors shall register with the commission at the time and in the manner determined by the commission.

(2) The commission shall maintain at its head office a register containing the name and address of each registered buyer and processor.

CHECK-OFFS AND OTHER CHARGES

Check-offs and other charges

15(1) Every registered producer engaged in the marketing of flax shall pay to the commission, at the times determined by the commission, a check-off calculated in accordance with this section.

(2) The check-off mentioned in subsection (1):

(a) is fixed at a rate of \$0.03 per bushel of flax seed and \$0.50 per tonne of flax straw marketed until the first annual general meeting of the registered producers is held; and

(b) after the period mentioned in clause (a):

(i) subject to subsection (3), is to be determined, by order of the commission, at the annual general meeting of the registered producers; and

(ii) is to be based on a fixed rate for every bushel of flax seed and tonne of flax straw marketed.

(3) Where it is anticipated that the level of check-offs will be determined by the commission at an annual general meeting of the registered producers, the commission shall provide at least 30 days' notice to registered producers that the level of check-offs is to be determined at that meeting.

(4) The commission shall make a refund of check-offs pursuant to section 6 of the Act only where:

(a) the producer submits the written request for the refund to the commission:

(i) with respect to check-offs paid between February 1 and July 31 in any year, not later than August 31 of that year; and

(ii) with respect to check-offs paid between August 1 in any year and January 31 in the following year, not later than February 28 of that year; and

(b) the request has been verified by the commission.

(5) Where the commission receives from a producer a written request in compliance with these regulations for a refund of check-offs:

(a) paid to the commission by the producer between February 1 and July 31 in any year, the commission shall make the refund of those check-offs to the producer not later than October 31 of that year; and

(b) paid to the commission by the producer between August 1 in any year and January 31 in the following year, the commission shall make the refund of those check-offs to the producer not later than April 30 of that year.

(6) The commission may require any processor, buyer or assembler of flax to:

(a) deduct check-offs and other fees and charges on flax levied pursuant to these regulations from any payments made to producers; and

(b) forward those check-offs, fees and charges to the commission.

(7) The commission may recover check-offs, fees and charges by suit in any court of competent jurisdiction.

MEETINGS

Meetings of producers

16(1) An annual general meeting of registered producers must be held before April 30 in each year at a time and place to be determined by the commission.

(2) Special general meetings of registered producers may be called by the commission at any time and must be called by the commission on the written request of 50 or more registered producers.

(3) The commission must give notice of a general meeting of registered producers by sending a notice, by ordinary mail, to each registered producer at least 30 days before the date of the meeting. (4) The quorum at a general meeting of registered producers is 25 registered producers.

(5) The commission shall prepare and submit to the annual general meeting of registered producers:

(a) a proposed budget outlining the collection and expenditure of funds during the next fiscal year; and

(b) an outline of proposed programs and activities for the next fiscal year.

(6) Registered producers may debate and take a poll at general meetings on any question or resolution related to flax.

(7) The remuneration to be paid to the members of the commission is to be fixed by the registered producers at the annual meeting.

ELECTIONS

Eligible voters

17(1) Every registered producer is eligible to vote for any purpose under the plan and to hold any office on the commission.

(2) A registered producer who is a corporation, co-operative, partnership, association, society or person carrying on business under a corporate name, trade name, farm name or other designation is entitled to vote or hold office:

(a) only through a designated representative appointed in writing; and

(b) only where notice of that appointment has been filed with the commission at the time of registration.

(3) Except as provided in subsection (2), voting by proxy is prohibited and each registered producer is entitled to one vote.

Election of first board

18(1) The interim commission shall conduct a vote among registered producers to elect a first board of directors in accordance with the other provisions of this section and section 19.

(2) The interim commission shall call the vote mentioned in subsection (1) within 18 months after these regulations come into force.

(3) The term of office of each member of the first board of directors commences on the day that the returning officer declares the director to be elected.

(4) The term of office of each member of the first board of directors ends at the close of the annual general meeting:

(a) in the case of the two registered producers receiving the largest numbers of votes, in the third year following the year in which the election is held;

(b) in the case of the two registered producers receiving the next largest numbers of votes, in the second year following the year in which the election is held; and

(c) in the case of the two registered producers receiving the next largest numbers of votes, in the first year following the year in which the election is held.

Conduct of elections

19(1) The commission shall arrange for the conduct of elections, fix a date for receiving nominations and, at least 30 days before that date, send to each registered producer a notice stating that nominations are being accepted for the election of directors and giving the date fixed for receiving nominations.

(2) The commission shall appoint a returning officer and a scrutineer who are not producers or employees of the commission.

(3) Every nomination is to be in writing, in the form prescribed by the commission, signed by three registered producers or their representatives and delivered to the returning officer not later than the date fixed for receiving nominations together with evidence satisfactory to the commission that the candidate is a producer.

(4) If not more than the maximum number of candidates are nominated, the candidates nominated are to be declared elected by acclamation.

(5) If more than the required number of candidates are nominated, the commission shall, at least 21 days prior to the date fixed for the election, send by prepaid post to each registered producer the ballot, a certificate of eligibility to vote, a plain envelope and a notice of the time by which and the place to which the ballot and certificate of eligibility to vote are to be returned.

(6) All voting is to be by ballot, and the ballot, sealed in the plain envelope provided, is to be returned to the returning officer appointed by the commission either in person or by mail, together with the certificate of eligibility to vote signed by the producer casting the ballot.

(7) No qualified voter shall vote for more than the specified number of candidates required to fill the vacancies.

(8) Those candidates receiving the most votes, up to the number of director's positions to be filled, are elected as directors.

(9) Ties are to be decided by the drawing of lots.

(10) The returning officer shall announce the names of the persons elected as directors at the close of the first annual general meeting of registered producers after the election.

(11) A registered producer is deemed to have received any notice, nomination paper or ballot that is posted to the registered producer at his or her last address registered with the commission, and the failure of any person to receive that notice, nomination paper or ballot does not invalidate the election.

(12) If any delay or irregularity occurs in any election, or if any doubt arises as to the validity of the election, the council shall determine who the directors of the board are, fix their terms of office and, if the council considers it advisable, direct the holding of a special directors' election.

Terms of office, vacancy, etc.

20(1) Subject to section 18, a director holds office for a term of three years, commencing with the announcement of the director's election by the returning officer.

(2) Where a director has completed two consecutive three-year terms, the director is not eligible for re-election until one year has passed since the completion of the director's second consecutive term.

(3) If a vacancy occurs on the board, the remaining directors may appoint a registered producer to fill the vacancy until the next election.

COMING INTO FORCE

Coming into force

21 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

3 The following subsection is added after subsection 11(1):

"(1.1) No person, while angling, shall catch and retain a sturgeon unless that person holds an angling licence and a sturgeon licence".

New section 14

4 Section 14 is repealed and the following substituted:

Prohibitions re possession limits

"14(1) No person shall possess more fish taken by angling from any zone than the maximum limits set out in Part I of Table 4.

(2) No person shall possess more fish taken by angling from the specific waters set out in Parts II to VI of Table 4 than the maximum limits set out in those Parts".

Section 15 amended

5 Section 15 is amended in the portion preceding clause (a) by striking out "angling limits or".

New section 16

6 Section 16 is repealed and the following substituted:

Sturgeon restriction

"16(1) No person who catches and retains a sturgeon pursuant to subsection 11(1.1) shall:

(a) fail to immediately record the appropriate information respecting that catch on his or her licence; or

- (b) give the sturgeon to any other person.
- (2) No person shall apply for more than one sturgeon licence in any year".

Section 38 amended

7 The following subsection is added after subsection 38(2):

"(3) No person shall store or possess fish taken pursuant to a subsistence fishing licence or pursuant to subsection 4(2) or (3) of the *Saskatchewan Fisheries Regulations, 1995* (Canada) at any place other than:

(a) the residence of the licensee or the person who has taken the fish pursuant to subsection 4(2) or (3) of the *Saskatchewan Fisheries Regulations, 1995* (Canada);

(b) the residence of the licensee's immediate family or the immediate family of the person who has taken the fish pursuant to subsection 4(2) or (3) of the *Saskatchewan Fisheries Regulations, 1995* (Canada); or

(c) a place authorized by an officer".

Title

1 These regulations may be cited as *The Vehicle Equipment Amendment Regulations, 1996.*

R.R.S. c.V-2.1 Reg 10 amended

2 *The Vehicle Equipment Regulations, 1987* are amended in the manner set forth in these regulations.

Section 2 amended

3 Subsection 2(1) is amended:

(a) in clause (p) by adding the words "or flashing lamp" after "beacon";

(b) by adding the following clause after clause (s):

"(s.1) **'flashing lamp'** means a lamp that emits a rotating or flashing light that is visible from the front or from the front and rear of the vehicle, but does not include head lamps, hazard lamps or turn signal lamps";

(c) by adding the following clause after clause (z):

"(z.1) '**loading lamp'** means a fixed lamp that emits a white light and that provides illumination behind a vehicle for the purpose of loading and unloading cargo and for coupling and uncoupling a trailer"; **and**

(d) by adding the following clauses after clause (kk.1):

"(kk.2) **'spotlamp'** means an articulated lamp that is attached to a vehicle that is capable of projecting a white light on an object and that is capable of being directed from within or outside of the vehicle;

"(kk.3) '**stationary lamp**' means a forward facing white lamp mounted above a standard headlamp system that is activated by a switch in the vehicle that is independent of the headlamp switch and electrical circuit".

New section 7

4 Section 7 is repealed and the following substituted:

Special equipment for certain vehicles

"7(1) A police vehicle may be fitted with the following equipment:

- (a) one or more red beacons mounted on the left side of the vehicle;
- (b) one or more blue beacons mounted on the right side of the vehicle;

(c) one or more red flashing lamps mounted on the left side of the vehicle facing front and rear;

(d) one or more blue flashing lamps mounted on the right side of the vehicle facing front and rear;

(e) a red or combination of a red and blue beacon or flashing lamp mounted on the dash or roof of the vehicle;

- (f) one or more stationary lamps;
- (g) one or more amber flashing lamps;
- (h) a siren.
- (2) An ambulance may be fitted with the following equipment:
 - (a) one or more red beacons;
 - (b) one or more white beacons;

(c) one or more red flashing lamps mounted on the front, rear and sides of the vehicle;

(d) one or more white flashing lamps mounted on the front, rear and sides of the vehicle;

- (e) one or more stationary lamps;
- (f) one or more amber flashing lamps;
- (g) a siren.
- (3) A fire-fighting vehicle may be fitted with the following equipment:
 - (a) one or more red beacons;

(b) one or more red flashing lamps mounted on the front, rear and sides of the vehicle;

- (c) a red beacon or flashing lamp mounted on the dash of the vehicle;
- (d) one or more stationary lamps;
- (e) one or more amber flashing lamps;
- (f) a siren.

(4) A vehicle approved as an emergency vehicle by the Highway Traffic Board may be fitted with the following equipment:

(a) one or more red beacons;

(b) one or more red flashing lamps mounted on the front, rear and sides of the vehicle;

- (c) a red beacon or flashing lamp mounted on the dash of the vehicle;
- (d) one or more stationary lamps;
- (e) one or more amber flashing lamps;
- (f) a siren.

(5) A type A vehicle that is a truck may be fitted with rear-facing loading lamps that emit a white light.

(6) A type A vehicle may be fitted with an articulated spot lamp that emits a white light to the rear.

(7) A tow truck is to be fitted with one or more amber beacons.

(8) A service truck, pilot car or vehicle creating a hazard on the highway may be fitted with:

- (a) one or more amber beacons; or
- (b) one or more amber flashing lamps.

(9) A vintage or modified vintage vehicle may have a blue lens 625 square millimetres or less as part of the tail-lamp assembly".

Coming into force

5 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
