# REVISED REGULATIONS OF SASKATCHEWAN

### CHAPTER G-5.1 REG 76

The Government Organization Act
Section 12

Order in Council 176/97, dated March 27, 1997

(Filed April 1, 1997)

#### Title

1 These regulations may be cited as The Department of Economic and Co-operative Development Regulations.

#### Department continued

2 The department of the Government of Saskatchewan called the Department of Economic Development is continued as the Department of Economic and Co-operative Development.

### Objects and purposes

- **3** The objects and purposes of the Department of Economic and Co-operative Development are:
  - (a) to provide the structure wherein and whereby the powers, responsibilities and functions of the Minister of Economic and Co-operative Development may be exercised and carried out;
  - (b) to co-ordinate, develop and implement policies, programs and strategies of the Government of Saskatchewan to encourage the growth and expansion of the Saskatchewan economy;
  - (c) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan that support and encourage the development and growth of co-operatives;
  - (d) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan that develop partnerships and working relationships between all sectors of the economy, including all levels of government and all persons, co-operatives, organizations and associations interested in the growth and expansion of the Saskatchewan economy;
  - (e) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan that provide business information and advice, and investment advice, to businesses, local governments, persons, co-operatives, organizations and associations;
  - (f) to research and investigate economic issues, strategies and opportunities;
  - (g) to consult with all sectors of the economy, including all levels of government and all persons, co-operatives, organizations and associations interested in the growth and expansion of the Saskatchewan economy;
  - (h) to co-ordinate all efforts by the Government of Saskatchewan related to economic issues, strategies and opportunities;
  - (i) to collect and disseminate information with respect to the growth and expansion of the Saskatchewan economy.

## **SASKATCHEWAN REGULATIONS 17/97**

The Saskatchewan Medical Care Insurance Act Section 48

Order in Council 177/97, dated March 27, 1997

(Filed March 31, 1997)

#### Title

1 These regulations may be cited as *The Medical Care Insurance Beneficiary and Administration Amendment Regulations*, 1997.

### R.R.S. c.S-29 Reg 13, section 10 amended

- 2 Clause 10(k) of *The Medical Care Insurance Beneficiary and Administration Regulations* is repealed and the following substituted:
  - "(k) advice by telephone, other than advice by telephone respecting a patient that is provided by a physician in response to a telephone request made by a health care provider who provides home care services to that patient".

#### Coming into force

- **3**(1) Subject to subsection (2), these regulations come into force on March 31, 1997.
- (2) If these regulations are filed with the Registrar of Regulations after March 31, 1997, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
