## CHAPTER H-0.001 REG 1

The Health Care Directives and Substitute Health Care Decision Makers Act

Section 25

Order in Council 634/1998, dated October 20, 1998

(Filed October 21, 1998)

#### Title

1 These regulations may be cited as The Health Care Directives and Substitute Health Care Decision Makers Regulations.

### Interpretation

2 In these regulations, "Act" means The Health Care Directives and Substitute Health Care Decision Makers Act.

## Prescribed ecclesiastical authorities and religious orders

**3** For the purposes of section 17 of the Act, the ecclesiastical authority set out in column B in the Appendix and designated by its religious order may make a health care decision for a member of the authority's religious order set out in column A.

## Coming into force

4 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

#### Title

1 These regulations may be cited as The School Bus Operating Amendment Regulations, 1998.
