#### SASKATCHEWAN REGULATIONS 26/2001

The Financial Administration Act, 1993

Sections 24 and 71

Order in Council 346/2001, dated May 1, 2001

(Filed May 2, 2001)

#### Title

1 These regulations may be cited as *The Livestock and Horticultural Facilities* (Education and Health Tax) Remission Amendment Regulations, 2001.

#### R.R.S. c.F-13.4 Reg 15 amended

**2** The Livestock and Horticultural Facilities (Education and Health Tax) Remission Regulations are amended in the manner set forth in these regulations.

#### Section 1 amended

**3** Section 1 is amended by striking out "Education and Health Tax" and substituting "Provincial Sales Tax".

#### Section 2 amended

**4** Clause **2(k)** is amended by striking out "The Education and Health Tax Act" and substituting "The Provincial Sales Tax Act".

#### Section 5 amended

5 Section 5 is amended by striking out "2001" and substituting "2004".

#### Section 5.1 amended

6 Section 5.1 is amended by striking out "2001" and substituting "2004".

#### Section 7 amended

7 Clause 7(1)(b) is amended by striking out "2001" and substituting "2004".

#### SASKATCHEWAN REGULATIONS 27/2001

The Fisheries Act (Saskatchewan), 1994

Order in Council 347/2001, dated May 1, 2001

(Filed May 2, 2001)

Title

**1** These regulations may be cited as *The Fisheries Amendment Regulations*, 2001.

#### R.R.S. c.F-16.1 Reg 1 amended

**2** The Fisheries Regulations are amended in the manner set forth in these regulations.

#### Section 2 amended

#### 3 Clause 2(u) is repealed and the following substituted:

"(u) **'resident'** means a person whose principal residence is in Saskatchewan and who has resided in Saskatchewan for the three-month period preceding the application for a licence".

#### Section 10 amended

#### 4 Clause 10(1)(c) is amended by adding "or weight" after "number".

#### Section 28 amended

#### 5 The following subsection is added after subsection 28(2):

"(3) Where the minister makes a designation pursuant to clause (1)(b) by weight, or limits the weight of each species that may be taken pursuant to clause 10(1)(c), that weight is with respect to round fish and the weight of dressed fish and headless dressed fish is to be converted to the weight of round fish by multiplying the weight by the following factors:

- (a) in the case of dressed fish, 1.2; and
- (b) in the case of headless dressed fish, 1.4".

Section 39 amended

#### 6(1) Section 39 is amended by renumbering it as subsection 39(1).

#### (2) The following subsection is added after subsection 39(1):

"(2) No person engaged in bait fishing in waters that are not Saskatchewan waters shall sell any bait fish, crayfish, leeches or aquatic invertebrates unless that person is the holder of a bait fishing licence".

Section 37

#### New section 85.1

#### 7 The following section is added after section 85:

#### "Disposal of equipment, etc.

**85.1** Any fishing gear, equipment, vehicle, aircraft, boat or other watercraft may be disposed of by auction, tender or any other means the minister considers appropriate where:

(a) the item has been forfeited to the Crown pursuant to the Act; or

(b) the item is to be returned to the person from whom it was seized and that person and anyone authorized to act on that person's behalf cannot be located".

8 Subsection 86(2) is amended by striking out ", sturgeon licence".

#### Section 87 amended

9 Subsection 87(1) is amended by striking out ", sturgeon licences".
