SASKATCHEWAN REGULATIONS 72/2001*The Milk Control Act, 1992*

Section 10

Board Order, dated October 16, 2001

(Filed October 16, 2001)

Title

1 These regulations may be cited as *The Milk Control Amendment Regulations, 2001 (No. 11)*.

R.R.S. c.M-15 Reg 1, Appendix amended

2 Subsection 3(1) of Part II of the Appendix to *The Milk Control Regulations* is amended:

- (a) in subclause (a)(i) by striking out “\$45.32” and substituting “\$46.28”;
- (b) in subclause (b)(i) by striking out “\$45.32” and substituting “\$46.28”;
- (c) in subclause (c)(i) by striking out “\$45.32” and substituting “\$46.28”; and
- (d) by repealing clauses (m) and (n) and substituting the following:
 - “(m) in the case of class 5a milk:
 - (i) \$8.4499 per kilogram of butterfat;
 - (ii) \$7.0700 per kilogram of protein; and
 - (iii) \$0.5420 per kilogram of other solids;
 - “(n) in the case of class 5b milk:
 - (i) \$8.4499 per kilogram of butterfat;
 - (ii) \$2.7984 per kilogram of protein; and
 - (iii) \$2.7984 per kilogram of other solids”.

Coming into force

“(6) Notwithstanding subsection (5), where the minister is of the opinion that there is a surplus in the account that is not needed for the purposes of the program, the minister may direct that the surplus be paid into the AIDA and CFIP Account continued pursuant to *The AIDA and CFIP Program Regulations*”.

- 2 The following subsection is added after subsection 4(6) of *The Waterfowl Damage Compensation Program Regulations*:**

“(7) Notwithstanding subsection (6), where the minister is of the opinion that there is a surplus in the account that is not needed for the purposes of the program, the minister may direct that the surplus be paid into the AIDA and CFIP Account continued pursuant to *The AIDA and CFIP Program Regulations*”.

The Police Act, 1990

Section 12

Title

- 1** These regulations may be cited as *The Municipal Police Clothing and Rank Amendment Regulations, 2001*.

R.R.S. c.P-15.01 Reg 1 amended

- 2** *The Municipal Police Clothing and Rank Regulations, 1991* are amended in the manner set forth in these regulations.

Section 4 amended

3 Subsection 4(3) is amended:

- (a) by striking out “or” after clause (h);**
 - (b) by adding “or” after clause (i); and**
 - (c) by adding the following clause after clause (i):**
- “(j) reflective vest”.

Section 9 amended

4 The following clause is added after clause 9(1)(e):

“(f) reflective vest - hi-visibility US101 Yellow with three layer Gore-Tex taslan navy contrast, one inch 3M silver reflective bands on the sleeves from shoulder to cuff and on the back in two horizontal bands, a single vertical band on each front breast pocket, velcro closures at the wrist, epaulets, microphone holder on the left chest, name tag holder on right chest, breast pockets with one-way zipper with velcro and snap closures, “POLICE” graphics on the left front chest and back, side zipper openings to fit around weapons and equipment, elastic shock cord bottom hem adjustment, all weather zipper with easy to grip zipper pull cord, charcoal grey fleece liner with front full-length zipper, and shoulder flashes but no other markings”.

Section 27 amended

5 Subsection 27(1) is amended in the portion preceding clause (a) by adding “, reflective vest” after “parka”.

The Queen's Bench Act, 1998

Section 109

Order in Council 768/2001, dated October 16, 2001

Title

1 These regulations may be cited as *The Queen's Bench Amendment Regulations, 2001*.

R.R.S. c.Q-1.01 Reg 1 amended

2 *The Queen's Bench Regulations* are amended in the manner set forth in these regulations.

New section 7.1

3 The following section is added after section 7:

“Parenting education

7.1(1) The judicial centres of Saskatoon and Yorkton are designated for the purposes of section 44.1 of the Act.

(2) The following are established as parenting education programs for the purposes of section 44.1 of the Act:

(a) parenting education programs provided by Family Law Support Services and Mediation Services of the Department of Justice;

(b) parenting education programs approved by the Minister of Justice.

(3) For the purposes of subsection 44.1(7) of the Act, Form D is prescribed as a certificate of attendance”.

7.1(1) Les centres judiciaires de Saskatoon et de Yorkton sont désignés aux fins de l'article 44.1 de la Loi.

(2) Les cours qui suivent sont établis en tant que cours sur l'art d'être parent aux fins de l'article 44.1 de la Loi :

a) les cours sur l'art d'être parent dispensés par les Services d'appui en droit de la famille et les Services de médiation du ministère de la Justice;

b) les cours sur l'art d'être parent approuvés par le ministre de la Justice.

(3) Pour l'application du paragraphe 44.1(7) de la Loi, la formule D est prescrite comme attestation de présence ».

Appendix, Part V amended

4 **Part V of the Appendix is amended by adding the following after the description of the Drumheller Wildlife Refuge:**

“EASTWOOD WILDLIFE REFUGE

Eastwood Wildlife Refuge consists of the following lands in Section 21, in Township 50, in Range 11, West of the Third Meridian:

- (a) the north-west quarter;
- (b) the north-east quarter, excepting 0.36 hectares for a Roadway as shown on Plan 85B04808”.
