SASKATCHEWAN REGULATIONS 98/2006*The Local Authority Freedom of Information
and Protection of Privacy Act*

Section 57

Order in Council 801/2006, dated October 17, 2006

(Filed October 18, 2006)

Title

1 These regulations may be cited as *The Local Authority Freedom of Information and Protection of Privacy Amendment Regulations, 2006*.

R.R.S. c.L-27.1 Reg 1, new section 8.1

2 **Section 8.1 of *The Local Authority Freedom of Information and Protection of Privacy Regulations* is repealed and the following substituted:**

“Confidentiality provisions in other enactments

8.1 For the purposes of clause 22(3)(a.1) of the Act, the following are prescribed as provisions to which subsection 22(1) of the Act does not apply:

- (a) subsections 171(5) and (6) and sections 201 and 202 of *The Cities Act*;
- (b) section 38 of *The Mental Health Services Act*;
- (c) subsections 201(5) and (6) and sections 231 and 232 of *The Municipalities Act*;
- (d) subsections 196(5) and (6) and sections 205.2 and 205.22 of *The Northern Municipalities Act*”.

Coming into force

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
