Order in Council 910/2006, dated December 12, 2006

(Filed December 13, 2006)

**Title**

1 These regulations may be cited as *The Beaverlodge Surface Lease Agreement Regulations, 2006*.

**Agreement re Surface Lease**

2 The Minister of Environment and the Minister of Northern Affairs are authorized to enter into and execute an agreement granting surface rights to CAMECO Corporation substantially in accordance with the provisions set out in the form of the agreement contained in the Appendix.

3 *The Beaverlodge Surface Lease Agreement Regulations* are repealed.

**Coming into force**

4 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**EXEMPTION FROM PUBLICATION**Re: *The Beaverlodge Surface Lease Agreement Regulations, 2006*

## Section 7

Order in Council 906/2006, dated December 12, 2006

(Filed December 13, 2006)

**Title**

**1** These regulations may be cited as *The Ethanol Fuel (General) Amendment Regulations, 2006 (No. 2)*.

**R.R.S. c.E-11.1 Reg 1, section 5 amended**

**2** **Subclauses 5(1)(a)(i) to (iv) of *The Ethanol Fuel (General) Regulations* are repealed and the following substituted:**

“(i) in the period commencing on November 1, 2005 and ending on January 14, 2007, 1.0% ethanol;

“(ii) in the period commencing on January 15, 2007 and ending on December 31, 2007, 7.5% ethanol; and

“(iii) in every one-year period commencing on January 1, 2008, 7.5% ethanol”.

**3** These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**1** These regulations may be cited as *The Mineral Exploration Tax Credit Amendment Regulations, 2006*.

**2** **Clause 2(2)(d) of *The Mineral Exploration Tax Credit Regulations* is amended by adding “, as that definition read immediately before January 1, 2006” after “subsection 127(9) of the ITA”.**

**3** These regulations come into force on the day on which they are filed with the Registrar of Regulations, but are retroactive and are deemed to have been in force on and after January 1, 2006.

**SASKATCHEWAN REGULATIONS 114/2006***The Income Tax Act, 2000*

Section 124

Order in Council 909/2006, dated December 12, 2006

(Filed December 13, 2006)

**Title**

1 These regulations may be cited as *The Income Tax Indexation Amendment Regulations, 2006*.

**R.R.S. c.I-2.01 Reg 3, section 2 amended**

2 **Section 2 of *The Income Tax Indexation Regulations* is amended by adding the following clause after clause (b):**

“(c) 2.2% for the 2007 taxation year”.

**Coming into force**

3(1) Subject to subsection (2), these regulations come into force on January 1, 2007.

(2) If these regulations are filed with the Registrar of Regulations after January 1, 2007, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
