SASKATCHEWAN REGULATIONS 31/2007

The Government Organization Act

Sections 19 and 24

and

The Human Resources, Labour and Employment Act

Section 4.01

Order in Council 326/2007, dated May 2, 2007

(Filed May 2, 2007)

Title

1 These regulations may be cited as *The Training Allowance Amendment Regulations, 2007*.

R.R.S. c.G-5.1 Reg 80 amended

2 *The Training Allowance Regulations* are amended in the manner set forth in these regulations.

Section 17 amended

3 **The following clause is added after clause 17(5)(r):**

“(s) any premium rebate paid pursuant to Division 3 of Part III.1 of *The Automobile Accident Insurance (General) Regulations, 2002* to the person as an eligible insured within the meaning of those regulations”.

New section 23.1

4 **The following section is added after section 23:**

“Certain amounts deemed not to be overpayments

23.1(1) In this section, ‘**increased amount**’ means the amount A calculated in accordance with the following formula:

$$A = B - C$$

where:

B is the amount of a training allowance that was paid to a person on or before the coming into force of these regulations and that was calculated on the basis of not including the amount mentioned in clause 17(5)(s) in the income of that person; and

C is the amount of a training allowance that would be calculated as including the amount mentioned in clause 17(5)(s) in the income of the person mentioned in the description of the amount B.

(2) Notwithstanding any other provision of these regulations, any increased amount paid to a person on or before the coming into force of *The Training Allowance Amendment Regulations, 2007* is deemed not to be an overpayment for the purposes of these regulations, and no person who received an increased amount is required to repay that increased amount”.

Coming into force

5 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

SASKATCHEWAN REGULATIONS 34/2007*The Saskatchewan Assistance Act*

Section 14

Order in Council 329/2007, dated May 2, 2007

Title

1 These regulations may be cited as *The Employment Supplement Amendment Regulations, 2007*.

R.R.S. c.S-8 Reg 3, section 32 amended

2(1) Section 32 of *The Employment Supplement Regulations* is amended in the manner set forth in this section.

(2) The formula in subsection (3) is amended by striking out “\$1,305” and substituting “\$1,520”.

(3) The formula in subsection (5) is amended by striking out “\$1,305” and substituting “\$1,520”.

Coming into force

3(1) Subject to subsection (2), these regulations come into force on May 1, 2007.

(2) If these regulations are filed with the Registrar of Regulations after May 1, 2007, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
