REVISED REGULATIONS OF SASKATCHEWAN

SASKATCHEWAN REGULATIONS 119/2007

The Labour Standards Act

Section 84

Order in Council 876/2007, dated November 8, 2007

(Filed November 8, 2007)

Title

1 These regulations may be cited as *The Labour Standards Amendment Regulations, 2007* (No. 4).

R.R.S. c.L-1 Reg 5, section 22 amended

2 Section 22 of *The Labour Standards Regulations, 1995* is amended by adding the following subsection after subsection (3):

“(4) The Government of Saskatchewan is exempted from giving any written notice pursuant to section 44.1 of the Act with respect to employees who are not within the scope of a collective bargaining agreement and are terminated within 30 days after polling day for a general election within the meaning of *The Election Act, 1996*”.

Coming into force

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
