- "(3.1) In renewing or extending an authorization to pay a skills training benefit pursuant to subsection (3), the minister shall state the total amount of the skills training benefit to be paid to that person".

where:

A is the maximum amount of the child allowance that may be allowed for the parent who is receiving the skills training benefit; and

N is the number of days in the month that the child resides with the parent who is receiving the skills training benefit".

New section 18

"Allowance over-rides and exemptions

18(1) On receipt of an exemption request, the minister may approve an allowance greater than the maximum amount set out in section 15, 16 or 17, as the case may be.

(2) The minister must approve an exemption request before the amount stated in the exemption request will be allowed".

Order in Council 580/2008, dated August 20, 2008 (Filed August 22, 2008)

Title

1 These regulations may be cited as *The Training Programs Amendment Regulations*, 2008.

R.R.S. c.D-22.01 Reg 1 amended

2 The Training Programs Regulations are amended in the manner set forth in these regulations.

Section 2 amended

- 3 Section 2 is amended:
 - (a) by repealing clause (a) and substituting the following:
 - "(a) 'adult basic education transcript' means an official record issued by the ministry over which the minister presides of an individual's marks for courses taken in an adult basic education program;
 - "(a.1) 'agreement' means a written agreement between the minister and an applicant respecting financial assistance"; and
 - (b) by adding the following clauses after clause (f):
 - "(f.1) 'general educational development diploma' means a credential that is recognized in Canada and the United States of America as equivalent to a high school diploma;
 - "(f.2) 'general educational development transcript' means an official record issued by the ministry over which the minister presides of an individual's scores for tests written towards obtaining a general educational development diploma".

Section 3 amended

 - "(a) to lead to employment for those participants in new job positions or vacant job positions".

(3) The following subsection is added after subsection 4(1):

"(2) Notwithstanding subsection (1), only employers who have 10 or fewer employees at the time of application are eligible to apply for financial assistance pursuant to this Part to hire participants in vacant job positions".

"(c.1) if being hired in a vacant job position, belong to a designated group as determined by the minister".

Section 6 amended

7 Clause 6(2)(b) is repealed and the following substituted:

- "(b) agree to hire participants only in new job positions or vacant job positions that the minister is satisfied will provide recognized on-the-job skills training;
- "(b.1) if applying for financial assistance to hire participants in vacant job positions:
 - (i) certify that the applicant has 10 or fewer employees; and
 - (ii) agree to only hire participants who belong to a designated group as determined by the minister in those vacant job positions".

"PART VII General Educational Development

"General Educational Development program

33 The purpose of the general educational development program is to assist individuals in obtaining a general educational development diploma.

"Application and approval to write

- **34**(1) Any individual who wishes to write or rewrite one or more tests of general educational development or to obtain a general educational development diploma or transcript shall:
 - (a) apply to the minister in a form acceptable to the minister; and
 - (b) pay the fees prescribed in this Part.
- (2) To be eligible to apply to write or rewrite a test of general educational development, an individual must:
 - (a) be 18 years of age or older; or
 - (b) be 17 years of age and have obtained the written approval of the minister to write or rewrite the test of general educational development that is applied for.

- (3) On receipt of an application pursuant to subsection (1) and if the minister is satisfied that the applicant has complied with this section, the minister shall:
 - (a) allow the applicant to write or rewrite the test of general educational development that was applied for; or
 - (b) provide the general educational development diploma or transcript that was applied for.
- (4) If an applicant fails to write or rewrite a test of general educational development that was applied for within one year after the date that the minister issued an authorization pursuant to clause (3)(a):
 - (a) the authorization expires; and
 - (b) the applicant must apply for a new authorization to write or rewrite the test of general educational development.

"Fees payable

- **35**(1) For the purposes of clause 34(1)(b), the following fees are required to be paid:
 - (a) for each battery of tests of general educational development, \$35;
 - (b) for each rewrite of all or any of the tests of general educational development, \$35;
 - (c) for each general educational development diploma, \$15;
 - (d) for a duplicate general educational development transcript requested by a student:
 - (i) for the first three copies requested, \$15;
 - (ii) for the fourth and subsequent copies requested, \$1 each;
 - (e) for a duplicate general educational development transcript requested by a person other than a student, \$15 for each copy requested.
- (2) A person is exempt from paying the general educational development registration fee as set out in clause (1)(a) or (b) if:
 - (a) the person is writing the tests of general educational development for the first time in any two-year period; and
 - (b) the person:
 - (i) is receiving:
 - (A) a benefit pursuant to The Training Allowance Regulations;
 - (B) assistance pursuant to the Saskatchewan Assistance Regulations, being Saskatchewan Regulations 78/66; or
 - (C) an allowance pursuant to *The Transitional Employment Allowance Regulations*; or
 - (ii) is residing in a correctional facility as defined in *The Correctional Services Act* and has taken a general educational preparation program.

"PART VII.1 Adult Basic Education

"Adult basic education program

35.1 The purpose of an adult basic education program is to assist adults in furthering their education at the primary or secondary education level.

"Application and courses

- **35.2**(1) Any individual who wishes to participate in an adult basic education program must:
 - (a) be 18 years of age or older;
 - (b) have been out of school for at least one year; and
 - (c) apply to participate in an adult basic education program offered by an organization that is approved by the minister.
- (2) An adult basic education program:
 - (a) must include credit courses; and
 - (b) may include non-credit courses.
- (3) An adult basic education credit course must follow curricula approved by the minister.

"Transcripts

- **35.3**(1) Any person who wishes to obtain an adult basic education transcript shall:
 - (a) apply to the minister in a form acceptable to the minister; and
 - (b) pay the fees prescribed in this Part.
- (2) On receipt of an application pursuant to subsection (1) and if the minister is satisfied that the applicant has complied with this Part, the minister shall provide the adult basic education transcript that was applied for.

"Fees payable

- **35.4** For the purposes of clause 35.3(1)(b), the following fees are required to be paid:
 - (a) for an adult basic education transcript requested by a student:
 - (i) for the first three copies requested, \$15;
 - (ii) for the fourth and subsequent copies requested, \$1 each;
 - (b) for a duplicate adult basic education transcript requested by a person other than a student, \$15 for each copy requested".

Coming into force

2 The Securities Commission (Adoption of National Instruments) Regulations are amended in the manner set forth in these regulations.

Part XXII of Appendix amended

- **3**(1) Part XXII of the Appendix is amended in the manner set forth in this section.
- (2) Section 1.1 is amended:
 - (a) in the definition of "foreign exchange-traded security":
 - (i) by striking out "only" wherever it appears; and
 - (ii) by adding "and is not listed on an exchange or quoted on a quotation and trade reporting system in Canada" after "International Organization of Securities Commissions";
 - (b) by repealing the definition of "member" and substituting the following:
 - "'member' means, for a recognized exchange, a person or company:
 - (a) holding at least one seat on the exchange; or
 - (b) that has been granted direct trading access rights by the exchange and is subject to regulatory oversight by the exchange;

and the person or company's representatives";

- (c) in clause (b) of the definition of "recognized exchange" by adding "or authorized by the securities regulatory authority" after "as a self-regulatory organization";
- (d) in the definition of "subscriber" by adding ", and the person or company's representatives" after "orders on the ATS";
- (e) by adding the following definition after the definition of "subscriber":
 - " 'trading fee' means the fee that a marketplace charges for the execution of a trade on that marketplace";
- (f) by repealing the definition of "transaction fee"; and
- (g) in the definition of "user" by adding ", and the person or company's representatives" after "on the recognized quotation and trade reporting system".

- (b) to the securities regulatory authority the information required by the securities regulatory authority under securities legislation, within ten business days, in electronic form".
