REVISED REGULATIONS OF SASKATCHEWAN

SASKATCHEWAN REGULATIONS 41/2009

The Milk Control Act, 1992

Section 10

Board Order, dated April 16, 2009

(Filed April 23, 2009)

Title

1 These regulations may be cited as The Milk Control Amendment Regulations, 2009 (No. 4).

R.R.S. c.M-15 Reg 1, Appendix amended

- 2 Subsection 3(1) of Part II of the Appendix to *The Milk Control Regulations* is amended by repealing clauses (m) to (o) and substituting the following:
 - "(m) in the case of class 5a milk:
 - (i) \$3.2328 per kilogram of butterfat;
 - (ii) \$5.7899 per kilogram of protein;
 - (iii) \$0.0001 per kilogram of other solids;
 - "(n) in the case of class 5b milk:
 - (i) \$3.2328 per kilogram of butterfat;
 - (ii) \$1.7910 per kilogram of protein;
 - (iii) \$1.7910 per kilogram of other solids;
 - "(o) in the case of class 5c milk:
 - (i) \$3.0000 per kilogram of butterfat;
 - (ii) \$1.6981 per kilogram of protein;
 - (iii) \$1.6981 per kilogram of other solids".

Coming into force

3 These regulations come into force on May 1, 2009.

SASKATCHEWAN REGULATIONS 42/2009

The Traffic Safety Act

Section 287

Order in Council 301/2009, dated April 22, 2009

(Filed April 23, 2009)

Title

1 These regulations may be cited as The Driver Licensing and Suspension Amendment Regulations, 2009.

R.R.S. c.T-18.1 Reg 2, new section 7

2 Section 7 of *The Driver Licensing and Suspension Regulations, 2006* is repealed and the following substituted:

"Class 5 driver's licence

- 7 Subject to any imposed restrictions on a class 5 driver's licence, the holder of the class 5 driver's licence may operate:
 - (a) class 5 motor vehicles;
 - (b) an emergency vehicle mentioned in clause 238(1)(e) of the Act but only if the holder of the class 5 driver's licence has successfully completed a driving course approved by the administrator for the operation of emergency vehicles; and
 - (c) any other vehicles that the holder of the driver's licence is entitled to operate by virtue of an endorsement placed by the administrator on the driver's licence, subject to the terms and conditions of the endorsement".

Coming into force

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

SASKATCHEWAN REGULATIONS 43/2009

The Traffic Safety Act

Section 287

Order in Council 302/2009, dated April 22, 2009

(Filed April 23, 2009)

Title

1 These regulations may be cited as The Vehicle Equipment Amendment Regulations, 2009.

R.R.S., c.V-2.1 Reg 10 amended

2 The Vehicle Equipment Regulations, 1987, are amended in the manner set forth in these regulations.

Section 2 amended

- 3 Clause 2(1)(q) is repealed and the following substituted:
 - "(q) 'emergency vehicle' means any of the following vehicles:
 - (i) a vehicle that is used for the transportation of a peace officer in the performance of the peace office's duties;
 - (ii) a vehicle that is used for the transportation of a member of a fire department in response to an emergency;
 - (iii) a vehicle that is an ambulance while being used in response to an emergency;
 - (iv) a vehicle that is a vehicle, or a member of a class of vehicles, designated by the board as an emergency vehicle and that is being used in response to an emergency;
 - (v) a vehicle that:
 - (A) is designated by a municipality in a bylaw pursuant to *The Traffic Safety Act* as a vehicle that may be used as an emergency vehicle by a volunteer firefighter or first responder; and
 - (B) is being used in response to an emergency and is operated by a person who meets the requirements prescribed pursuant to *The Traffic Safety Act*".

Section 7 amended

- 4 The following subsections are added after subsection 7(4):
- "(4.1) Subject to subsection (4.2), an emergency vehicle within the meaning of subclause 2(1)(q)(v) may be fitted with the following equipment:
 - (a) a red beacon or red flashing light that:
 - (i) meets SAE standard J845 or J1318 class 1 requirements; and
 - (ii) is mounted on the dash, front or roof of the emergency vehicle; and
 - (b) a siren that meets SAE standard J1849.

"(4.2) A person operating an emergency vehicle within the meaning of subclause 2(1)(q)(v) must remove, or cover with an opaque cover, the red beacon or red flashing light mentioned in clause (4.1)(a) when that emergency vehicle is not being used in response to an emergency".

Coming into force

5 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

SASKATCHEWAN REGULATIONS 44/2009

The Labour Standards Act

Section 84

Order in Council 303/2009, dated April 22, 2009

(Filed April 23, 2009)

Title

1 These regulations may be cited as *The Labour Standards Amendment Regulations*, 2009.

R.R.S. c.L-1 Reg 5, section 9 repealed

2 Section 9 of The Labour Standards Regulations, 1995 is repealed.

Application of regulation

- **3**(1) In this section, "**services**" means services related to designing, constructing, repairing or maintaining a highway, or assisting in those activities, where work on a highway is being performed:
 - (a) outside a city, town or village; or
 - (b) from a point or points outside any city, town or village into or through that city, town or village.
- (2) Notwithstanding section 2, section 9 of *The Labour Standards Regulations*, 1995 continues to apply, and remains in force, but only with respect to:
 - (a) services that are the subject of a contract that was entered into before these regulations came into force until that contract expires or is terminated; and
 - (b) the employees and employers who are governed by the contract described in clause (a).

Coming into force

4 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
